- c. Councillor Waterman discussed the <u>naming of the roundabouts</u>. This Is an ongoing topic of the Commission . The Jubilee/Rosedale roundabout would be the "MacDonald Roundabout "to honour S.A. MacDonald and Macdonald School. The Prairie Valley/Rosedale Roundabout proposal is the Pierre Roundabout named after Antoine Pierre the first recorded resident of that area. The Victoria/Prairie Valley Road roundabout proposed name is the "Fraser Smith" roundabout, named after a well known citizen who was killed at that interesection.
- d. <u>West Summerland Train Station Site</u>. The Commission requested the status of the plan for some heritage features at the former West Summerland Train Station. Blueprints are available to re-construct the building in the future. The Commission had chosen the West Summerland Train Station site for the 2014 heritage site.
