Dog Days

The temporary off-leash period at Peach Orchard Park came to an end on April 30. Dogs are required to be leashed at all times on park trails. Dogs will be allowed off-leash at Peach Orchard Park starting



October 1. Dogs are allowed off-leash year-round at Peach Orchard Dog Beach. Reminder to all dog owners to keep Summerland clean by picking up after your dog, using dog-waste bags, dispensers and garbage cans.



Did you know you can purchase high quality, sustainable, and safe Class A biosolid compost at the Summerland Sanitary Landfill? Biosolid compost is valued for its high organic matter content and strong structure that drains easily and promotes healthy root growth. The Class A government designation means that the product can be sold with no restrictions. It can be safely applied to lawns, flowers, shrubs and gardens. **Using District of Summerland Compost in the spring is a great way to set the stage for the planting season!**

For the safety of users and staff, stay in your vehicle during loading

- Residents may also self-load compost products into owner supplied containers during regular landfill hours (bring your own shovel), or
- A loader is available Mondays through Fridays, 9:00am to 2:45pm (not available between 12 noon and 12:30pm)
- Compost: 4 cents/kilogram, Wood Mulch and Topdressing: 6 cents/kilogram
- \$2.00 minimum charge
- A 25% discount will be applied for loads over 1 metric tonne

Agriculture Water Usage Data

In order to provide Agricultural water users with timely data, the District posts monthly consumption reports on the website www.summerland.ca. Click on City Services - Water - Agricultural Water to access the consumption reports. Search by meter number using Ctrl + f and enter meter number in search box. If users prefer to monitor consumption manually, please take note of the meter read (indicated in the recent letter sent) and check the meter yourself to make sure the 800mm allotment is not exceeded. Prepare Your Family For An Outage

Most power outages will be over almost as soon as they begin, but some can last much longer - up to days or even weeks. Power outages are often caused by freezing rain, sleet storms and/or high winds which damage power lines and equipment. During a power outage, you may be left without heating/air conditioning, lighting, hot water, or even running water. You may also be left without phone or internet service. If you do not have a battery-powered or crank radio, you may have no way of monitoring news broadcasts. In other words, you could be facing major challenges.

You can greatly lessen the impact of a power outage by taking the time to prepare in advance. You and your family should be prepared to cope on your own during a power outage for at least 72 hours.

Giant's Head Mountain Park






The morning and Sunday road closures will allow for more space for park users to utilize the road for biking and hiking on the road without conflict with vehicles.

Plant Smart, Stay Safe

If you have a power line on or near your property, it doesn't mean you can't plant trees. The safest bet is to plan ahead so trees won't interfere with power lines no matter how tall they grow. Here are a few guidelines that will help you ensure your trees won't grow into hazardous trees.

Trees planted closer than 7.5 metres should be low-growing varieties. Nothing should be planted closer than 5 metres from the base of a power pole. If you have a secondary line connecting your home to a power line, avoid planting trees that will grow into the line. If you don't see a secondary line connected to your house, your secondary line is underground.

Property taxes will be **due by 4:00pm on Friday, July 2, 2021.**

Reminder that as of January 1, 2021, the Province of BC is now managing the Home Owner Grant (HOG). To avoid penalties and interest, homeowners need to apply for their HOG directly to the Province using an online system prior to the property tax deadline of July 2, 2021. Program eligibility has not changed, however, homeowners can no longer apply for their HOG at Municipal Hall.

Be Bear Smart - Place Your Carts at the Curb As Close As Possible to Your Collection Time

Garbage, bird feeders and tree fruits can attract bears to your yard, family and neighbourhood. Once a bear becomes used to human food sources it becomes habituated, usually resulting in the bear being destroyed. It is important to keep wildlife wild and communities safe.



Tips to prevent attracting bears to your property:

- Garbage properly secure garbage and keep it indoors until pick-up
 or until you can bring it to the landfill. <u>Do not place your carts at the
 curb the night before your collection day. Rather, bring your carts to
 the curb as close as possible to your collection time.</u> Consider
 upgrading to a wildlife cart.
- **Compost** properly care for your compost by turning it and layering it appropriately to reduce odours.
- Fruit Trees and Grapes- make sure to harvest fruit immediately.
- Pet food, Birdfeeders and Gardens are all attractants for bears.
 Keep your pet food securely stored indoors.
- **Barbeques** limit smells by keeping your barbeque properly cleaned, covered and don't leave utensils out overnight.

Please be reminded that the District of Summerland does not permit permanent or temporary signs to be placed in the roundabouts, on power poles or light standards or anywhere within highway rights-of-way, unless expressly permitted in Sign Bylaw No. 2013-026. The District may remove and impound any sign on District road rights-of-way that is in contravention with this Bylaw. Parking a vehicle on roadways to display for sale is in contravention of Section 5.05(1)(j)(i) of the Traffic Bylaw.
