### ADDENDUM


**5.** A discussion took place on the origin of the Heritage Advisory Commission in 1995. Originally Heritage activities were the responsibilities of the Summerland Museum and Heritage Society. The Society was the group that conducted Summerland's only detailed heritage inventory in 1989. (there has not been an update of the inventory since then). Also in 1988 the only valley-wide heritage inventory took place. Summerland had the highest number of heritage buildings in the Okanagan Valley.

The Heritage Advisory Commission took over the responsibilities of the 'heritage' portion of the Summerland Museum and Heritage Society. The activities of the Society continue with the annual selection of a heritage building and site and the annual pen and ink drawing (next year will be the 30<sup>th</sup> year)

5b. Previously the Councillor in attendance at the Commission would provide Commission recommendations to Council. This responsibility will now be the responsibility of staff, provided that staff member was in attendance.

6a. The Commission members agreed to assist municipal staff in pursuing grants for heritage activities. B.C. Heritage Week takes place on February 15-22. The theme this year is "Distinctive Destinations". With Summerland's Kettle Valley Steam Railway and its founder, Canadian Pacific Railway President Lord Shaughnessy, developing a theme will be easier than most communities.

6b. A major concern of the Commission is the condition of the sod roof cabin at Illahie in Trout Creek. This is one of Summerland and the Okanagan Valley's most important heritage building. The building is believed to have been built in 1888 by the cattlemen of the Thomas Ellis Ranch. A portion of Trout Creek Point was owned by Thomas Ellis.



#### HISTORY

Because of the delay in development, nothing has been done to protect the building and further delays could make restoration difficult -built in the mid 1880's

- -built by Tom Ellis cattlemen
- -owners have included Lt Governor Bulyea.
- -Herbert Dunham, Claude Evans, Harry
- -Thornwaite, Tom Hickey, Jacques Landry, -Gartrell family

Originally the Heritage Commission had come to agreement with the developers of the property is spend \$25,000 to rehabilitate the structure. But the building is now owned by new developers.

7d One of the heritage signs at the Fur Brigade Trail Linear Park was stolen. The possibility exists that the sign was removed from its stand and thrown away, so before efforts are made to purchase a new sign, attempts will be made to hunt for the missing sign.
