## Senior's Housing Development Proposed

An application has been made to construct a 380 unit seniors housing complex with a mixture of market housing, independent, and assisted living units at a property on Banks Crescent. On November 14th, 2016 two bylaws were introduced and given first reading to amend the Official Community Plan to change the future land use designation from Agriculture to High Density Residential (HDR). The application is also to amend the Zoning Bylaw to change the zone from A1 - Agricultural Small Acreage Zone to CD8 - Comprehensive Development Zone 8.

The current zoning amendment is to create a new Comprehensive Development Zone to permit a seniors housing project comprised of 5 separate buildings. The buildings are intended to include approximately 230 units of market housing for seniors, 100 units of independent living and 50 units of assisted living. The concept is to allow seniors to age in place and move to different sections of the development as they age and require greater levels of care.

The development is predominantly six storeys in height over three levels of underground parking. The living space will be constructed of wood frame over the concrete parking structure. The proposal includes amenities for residents, staff and visitors.

Council recognizes the magnitude of this comprehensive development and would like the community to have the opportunity to provide and receive information before any decisions are made. The Developer held a public open house December 6th and the District will be holding two separate public sessions (details are listed below). Please plan to attend. ### Clear Sidewalks Bordering your Property

Municipal Bylaws require that you remove the snow and ice from public footpaths and sidewalks bordering your property (business and residential). **Any snow or ice that accumulates before noon must be removed by noon that day. If snow falls in the afternoon, you have until noon of the next day to remove it.** Failure to do so could result in the District having the sidewalk cleaned at your expense. We ask that you use a de-icing agent that contains "CMA" for sidewalks, please do not use salt as it can cause damage. Please help to keep Summerland's sidewalks safe for all that use them.

### Project Updates

#### Jones Flat & Garnet Valley Water System Separation

At the Pre-construction Open House on November 3rd, the District introduced Pyramid Excavation Ltd. as the contractor that has been selected to complete this project. Since the open house, construction has started in the Jones Flat area with the installation of a new water main and services along Blair Street, Garnet Avenue and Tingley Street and the south end of Garnet Valley Road up to Jones Flat Road. If the weather cooperates, Pyramid may begin construction on Jones Flat Road towards Watson Avenue. ### Snow Removal

District crews are on call seven days a week to provide essential services to our residents. There are four trucks equipped with sanders and ploughs as well as a salter and a sweeper truck that work diligently to clear Summerland's roads throughout the winter. Staff also clear sidewalks and walkways that are not bordering private property. Heavy snow fall (3" or more) may require additional resources such as a grader and/or a loader to widen the road. Designated routes take approximately eight hours to complete once it has stopped snowing. Each route has its priority areas (e.g. bus routes) that must be revisited if snow continues to fall, therefore it may take some time before side streets are tended to. Equipment failures also play a role in delays. Contractors assist District staff with snow removal as well.

To help our staff, we ask that you do not park your vehicle(s) on the road and when you clear your driveway it is recommended that you stockpile on the right side of the driveway when facing the road. This prevents the snow from being ploughed back in front of your driveway by our equipment. Your patience is appreciated.
