

## Message from Mayor and Council

Phases 3 and 4 of the Giant's Head Mountain Trails Redevelopment Project is now underway. Final design work will be completed this year with construction beginning next spring. Completion date is scheduled for 2025.

Work will include improvements to the upper section of the Grind Trail and connecting trails as well as erosion control, brush removal and fire hazard remediation, and remedial planting and invasive weed management.

There will also be a new washroom at the park entrance, improvements to the upper parking lot washroom, and park road upgrades.

An Indigenous interpretive sign is now in place at the upper parking lot and there will be continued collaboration with the Penticton Indian Band (PIB) and Okanagan Nation Alliance (ONA) for additional interpretive signage.

The project received an official kick-off on June 9 with a blessing from sylix knowledge keeper Richard Armstrong and the unveiling of the interpretive sign. As mayor, I had the honour of hosting the event and introducing PIB Chief Greg Gabriel and Municipal Affairs Minister Anne Kang, who were both present to say a few words of congratulations and speak about how the project demonstrated the value of working in partnership. Also in attendance were MLA Dan Ashton, several members of Council, and representatives from the ONA, Summerland Rotary Club, Associated Engineering (project consultants), District of Summerland staff, and members of the media.

Phases 3/4 is a \$1,682,782 project with contributions coming from the Government of Canada (\$673,113), Government of British Columbia (\$560,871) and District of Summerland (\$448,798). Phases 1 and 2, completed in 2020, were also funded by all three levels of government as well as donations from Summerland Rotary.

## **Extended hours at Municipal Hall**

Starting July 2, 2023, Municipal Hall will trial extended service hours for customers by compressing full-time hours into a four-day period, from Tuesday to Friday. The trial will be 18 months and will apply to most Municipal Hall staff. Counter services will be provided Tuesday through Friday from 8:15 AM to 5:00 PM.

To ensure operational efficiency, some services will remain on a different schedule. Development Services, Bylaw Services, and Corporate Services will operate on a five -day schedule and by appointment-only on Mondays (when counter services are not operational).

# Victoria Road South project

A storm drainage and road improvement project will be taking place on Victoria Road South between Agur Street and Dunham Crescent. Work will include the replacement of storm drainage infrastructure, road reconstruction and the



installation of a multi-use pathway lane. Work is anticipated to start in the summer and be completed this fall.

This cranesbill geranium is winter hardy, (returns every year) resists deer, road salt, and heat and will bloom for many weeks in spring and summer. It also has a brilliant orange fall colour. It is currently blooming in front of the post office and firehall.

# Property tax notices

The 2022 Property Tax due date was **July 7**, **2023** at **5:00 PM**. Effective July 8, 2023 unpaid 2023 Property Taxes (including unclaimed Home Owner Grants) are now subject to a 10% penalty.

You may still claim the HOG online at <a href="www.gov.bc.ca/homeownergrant">www.gov.bc.ca/homeownergrant</a> or phone the Province of BC **1-888-355-2700**. Retroactive home owner grant applications are accepted up to December 31st each year.

The District of Summerland offers a Pre-Authorized Payment Program for property taxes - eleven (11) equal payments will be withdrawn from your bank account, starting August 15th each year. The final twelfth (12th) payment will be the difference between the actual amount of the current tax bill and pre-payments collected, plus interest earned up to the tax due date.

### Jubilee Road project

Watermain replacement and road reconstruction will be taking place on Jubilee Road West between Kelly Avenue and Rosedale Avenue. The project will include installation of a



bike path and new curbing at the Kelly Avenue intersection to improve safety for pedestrians and cyclists. Work will commence this summer during the school's summer break. Expect temporary closures during this time.

Due to the success of the temporary fenced dog park at Dale Meadows Sports Complex, permanent fencing has been installed and the footprint has been expanded. #### Agricultural user meter readings

#### Summerland Landfill recycling depot

Did you know that you do not have to cross the scale to access the Recycling Depot? When arriving at the landfill, keep to the right to access recycling only.



The following residential items are accepted <u>free</u> of charge year-round:

- Smoke detectors & alarms
- Residential cardboard & paper
- Flexible plastic packaging including plastic bags, overwrap, plastic pouches, wrappers, onion nets & other soft packaging made of plastic
- Lighting—fixtures and bulbs
- Foam Packaging (white and coloured) such as foam containers for meat & produce, foam egg cartons, foam clamshells, cups & bowls for takeout food, firm foam cushion packaging to protect electronics, small appliances, etc.
- Glass clear or coloured food containers, jars, non-refundable bottles
- Batteries including household batteries, small rechargeable & lead-acid batteries
- Electronic waste—computers, TVs, stereos, DVD players, phones, small electrical appliances

Crossing the scale gives access to many other <u>free</u> residential recycling opportunities:

- Commercial cardboard
- Household hazardous waste—paint, pesticides, flammables, antifreeze, gas, fuels, mixed fuels, paint thinner, solvent, aerosol cans, fluorescent light tubes
- Used motor oil, filters and containers
- Propane tanks, refillable or non-refillable—up to 46kg
- Metal/Scrap Metal—siding, roofing, rebar, pipes, window frames, doors, furnaces, duct work, wire cable, fencing, autobody parts, BBQs, metal furniture, tire rims
- White Goods—washers, dryers, dishwashers, fridges, stoves, freezers, hot water tanks, air conditioners

### **2024 Permissive Tax Exemptions**

2024 Not-For-Profit Permissive Tax Exemption (PTE) applications are now available.

Not-for-profit organizations that provide a service to the community may be eligible for a reduction in property taxes if the facility they operate from is owned or leased by the organization. This reduction in property taxes payable is considered a "Permissive Tax Exemption". Potential applicants can find eligibility criteria, along with the required application on the District of Summerland website at: <a href="https://www.summerland.ca/pte">www.summerland.ca/pte</a>.

All applicants will be requested to attend a council meeting as part of the 2024 PTE application process. The Permissive Tax Exemption submission deadline is <u>July 31</u>, <u>2023</u>.

#### **Puncturevine season**

There is very little puncturevine in Summerland, so please REPORT this plant to <a href="mailto:0ASISS@shaw.ca">0ASISS@shaw.ca</a>.

Puncturevine is an invasive annual introduced from Mediterranean areas. It is a low growing plant that matures



from a taproot and branches in all directions up to 3 metres in length. The stems are covered by hairy leaves that are divided into six to eight leaflets. Flowers are small and yellow. The fruit is a roughly circular, hard spiny bud with five sections that split when mature. Each section has two spines that are so sharp and hard they can pop bike tires, puncture shoe soles or embed in dogs' paws. It typically infests vacant lots, gravel parking areas, roadsides, unpaved trails and beaches. Handpulling can provide good control if done prior to seed formation. If done after seed set, pick up any loose seedpods and place in the garbage to prevent re-infestation.
