# **ELECTOR RESPONSE FORM**Alternative Approval Process

## District of Summerland Loan Authorization Bylaw – Wastewater Treatment Plant Upgrades No. 2024-005

Pursuant to sections 84 and 86 of the *Community Charter*, the District of Summerland is seeking the assent of the electors of the District of Summerland through an alternative approval process. The question before the electors is whether they are **OPPOSED** to the District of Summerland Council adopting the *District of Summerland Loan Authorization Bylaw Wastewater Treatment Plant Upgrades - No. 2024-005* which authorizes the borrowing not to exceed the sum of one million, two hundred thirty-two thousand dollars (\$1,232,000.00) to be repaid over a period not exceeding twenty (20) years, in order to finance the Wastewater Treatment Plant Upgrades.

#### **INSTRUCTIONS:**

- 1. If you are **OPPOSED** to the District adopting this bylaw and <u>you qualify as an elector of the District of Summerland</u>, you can sign and return an elector response form by **5:00 p.m. on April 9<sup>th</sup>, 2024** (see reverse).
- 2. If you are **NOT OPPOSED** to the District adopting this bylaw, you do not need to do anything.
- 3. To sign an elector response form, you MUST meet the qualifications as either a Resident Elector or a Non-Resident Property Elector. Non-resident Property Electors must have the written consent of a majority of the property owners to sign the response form on their behalf (see reverse). Property owned in whole or in part by a corporation does not qualify under the non-resident property elector provisions.
- 4. Each Elector Response Form may be signed by one elector of the District of Summerland.

Elector responses must be given in this Elector Response Form.

Additional Elector Response Forms are available at the District Municipal Hall. The only persons entitled to sign this form are electors of the District of Summerland.

Elector Response Forms may be submitted by hand delivery, by mail, by facsimile (fax), or by email as PDF document.

Council of the District of Summerland may proceed with this matter unless, by 5:00 p.m. on April 9<sup>th</sup>, 2024, at least 10% of the electors of the area indicate that Council must obtain the assent of electors before proceeding.

The number of electors in the District of Summerland is estimated to be 10,130. If ten (10%) percent [1,013] of the estimated number of electors in the District of Summerland sign an elector response form in **opposition** to the bylaw, the District of Summerland cannot proceed without receiving the assent of the electors by assent vote (referendum).
