8108 Purves Road (Z21-21-003)


Bylaw No. 2021-008 and Bylaw No. 2021-009 The intent of the proposed bylaws is:

• To change the future land use designation of the subject property (8108 Purves Road) from Low Density Residential to Low Density Residential (Intensification) and to add site-specific zoning regulations for the subject property to the RDH -**Residential Duplex Zone** for minimum lot area and minimum lot width to facilitate the subdivision and construction of two front-back duplex buildings.

Public Hearing #2 – Zoning Bylaw Amendment: 10518 Jubilee Road West (Z21-007)

Bylaw No. 2021-031 The intent of the proposed bylaw is:

 To change the zoning designation of the subject property (10518 Jubilee Road West) from Residential Single Detached Zone (RSD1) to Residential Medium Density Zone (RMD) to facilitate a multifamily development.
