**2026 SUMMERLAND BEACH VENDING  
Application Form**

The District of Summerland is accepting applications for food truck or food cart vendors to provide food and beverage services at our local beaches.

**Please read and understand all terms and conditions stated herein as they form an integral part of the Beach Vending Agreement and continued tenure is dependent on adherence to these requirements.**

Deadline for the first application review is **April 1, 2026**; applications received after April 1, 2026 will be considered upon receipt and dependent on space availability for additional vendors.

Vendors may want to ensure their application is approved before investing in licencing, insurance, and other related fees. If a vending application is approved, the vendor is required to provide all required documents and the first installment of the vendor licence fee prior to obtaining a License of Occupation for beach vending.





The District reserves the right to delete or alter the products and services that can be vended from various sites prior to awarding the Agreement.

Vendors can be disqualified or their license terminated at the sole discretion of the District for:

- failure to complying with any of the requirements, terms and conditions as set out in the Beach Vending Application and License of Occupation agreement;
- using or selling products that are perceived by the District to present a safety hazard or risk, or are otherwise not approved by the District for use or sale at the License Area; and
- unprofessional or inappropriate vendor conduct including, but not limited to, illegal activities, consumption of alcohol or drugs, use of profane language, actively soliciting or harassing pedestrians walking by, unacceptable customer service, or smoking within the vendor area; and
- failure to adhere to permitted vending locations.

Any illegal activities at the site will result in immediate termination of your mobile vending permit and will be dealt with by the RCMP.

### **Vendor Requirements**

Approved vendors are required to:

- complete and sign the 2026 Summerland Beach Vending Application;
- have a self-contained truck or cart (generators are permitted but must not disturb users of the park/beach or surrounding neighbours; requests for access to electrical outlets will be considered on a case-by-case basis and may result in additional fees);
- sign and agree to the terms outlined in the Beach Vending License of Occupation agreement (see sample template);
- provide proof of Liability, Property, and Automobile Insurance policies as outlined in the License of Occupation agreement;
- provide a copy of a Business Licence that allows the Licensee to perform work in Summerland (either a Summerland Business Licence or an Inter-Community/Mobile Business Licence from another Okanagan-Similkameen municipality).
- complete a Mobile Vendor inspection by the Fire Department (mobile vending equipment must bear the appropriate approval labels for Gas and Electrical equipment as required by Technical Safety BC, this includes custom built and home built units – contact TSBC at 1-866-566-7233 if you require further clarification);
- comply with all applicable health and food safety guidelines and regulations and provide a copy of a valid Food Safe certification;
- comply at all times with all employment standards and workers compensation regulations;
- ensure compliance with Provincial Health Orders; and
- submit fees in the amounts and schedule as outlined in the next section.

### **Fees**

The 2026 seasonal beach vending license fee is \$700.00 plus GST.

The season term is between May 15 – September 30, 2026. No prorated fees.

Half of the license fee (\$350.00) plus GST is due on or before the date of signing of the License of Occupation agreement and the remaining half of the license fee (\$350.00) plus GST is due on or before August 1, 2026. **No refunds will be issued after payment.**

### **Beach Vending Locations**

Approved vendors are permitted to park/set up in designated locations at the following Beach locations:

- Peach Orchard Beach – 14877 Lakeshore Drive (2 locations available)
- Rotary Beach – 13827 Lakeshore Drive (2 locations available)
- Powell Beach – 6511 Powell Beach Road (3 locations available)

Vending hours are available between 8:00 am – 9:00 pm. Vendors must remove trucks/equipment from the beach at the end of each day.

A limited number of vendors will be approved each season. Approved vendors may set up in any of the designated locations on a first-come, first-available basis each morning. It is recommended that approved vendors share contact information and coordinate a mutually agreed schedule.

### **Maintenance & Operation Requirements**

All vendors shall have suitable garbage collection arrangements, keep the vending area clean while doing business and ensure it is left clean. Vendors are required to have a professional looking and clean setup and signage. Vendors who leave their site dirty and un-kept may be charged for the clean-up expenses and/or have their permit cancelled. Vendors who do not maintain a professional looking setup or uphold professional customer service may have their permit cancelled.

All vehicles must be legally parked and operated safely in the designated locations. Vendors must obey all relevant Municipal, Provincial and Federal laws, statutes, etc. regarding vehicle use on roads, sidewalks, etc. Vendors who operate their vehicles illegally may be ticketed and have their vending permit suspended or terminated without reimbursement.

Vendors shall not do business outside their specified areas and to do so is in contravention of the terms of this agreement and may result in termination of the vendor's license without refund or reimbursement and/or ticketing.

Vendors are responsible for all driving infractions, vehicle fees and/or fines incurred in the course of doing business.

### **Authorization of Application**
