I cannot believe that more than a year has passed since this Council was elected in October of 2018. Highlights from this year include:

- Dog Parks, Pickleball and Tennis: Draft report on potential sites presented at an Open House for public comment
- Summerland Skatepark: Grand opening
- Solar and Battery Project: Preferred location report completed, and public comments received; awaiting results of site soil assessment
- Asset Management Policy, Strategy and Road Map: Completed
- Eneas Creek Strategy: Assessment and Open Houses completed; awaiting feedback from Ministry
- South Okanagan Food Innovation Hub: Successful in Pre-Qualification process; Proposal being submitted January 2020
- Wharton Property: Sale completed; Hillcrest Village scheduled to open early Spring 2020
- Active Transportation Plan: Completed and adopted by Council
- Giant's Head Mountain Trail: Phases I and II substantially completed
- Utility Rate Review and Open House: Completed, to be adopted by Council December 9
- Water Master Plan: Draft report completed; to be presented to Council December
- Community Energy and Emissions Reduction Plan: Draft report and open house completed
- Aquatic and Fitness Centre: Discussions with several partners and with Provincial ministries are ongoing
- Development Process Improvement Committee: Terms of reference completed; Council to appoint members in December
- Chief Administrative Officer and Corporate Officer recruitment: Completed

Council believes that working with all levels of government, including the School District board and the Penticton Indian Band, is the foundation of good governance. We are confident that this solid base, combined with a dedicated District staff and an engaged community, will see us through another productive year in 2020.

SUMMERLAND RECEIVES PRESTIGIOUS WATER AWARD

The District of Summerland is excited to announce they are the proud recipient of the Brian Harvey Award of Excellence from the Water Supply Association of BC. This award is given to a Public or Corporate Body that has demonstrated a high standard of service to the public. This is not necessarily given out annually, only when there is a deserving recipient who has proven excellence in innovative or unique solutions to water supply/quality problems, efficiency improvements, water/energy conservation as well as employee training, public information and money management.



Summerland earned the award by actions taken to ensure the District has safe drinking water and ample water for residents and agricultural

Over the years, Summerland made water its priority by raising Thirsk Dam to stabilize the raw water supply, building a Water Treatment Plant (WTP), and creating a Water Master Plan that provided quidance to water system separation, supply stability and water use efficiencies.

The Prairie Valley area was separated in 2009/10 to reduce the amount being treated by the WTP. Later the Garnet Valley area was separated to provide domestic water from the WTP to customers and open up more capacity for irrigation water from the Garnet Reservoir to service the agricultural lands in the community. In an effort to conserve water, a metering program took place with a pricing system based on allocation of set flow rates and annual depths to arable land parcels. The District continues to work to provide outstanding service and water to its residents.

For safety reasons, it is important that snow is cleared from sidewalks. For some this task can be very difficult. Snow Angel is a snow removal awareness and recognition program to encourage

SIDEWALK CLEARING

Municipal bylaws require that you remove the snow and ice from public footpaths and sidewalks bordering your property (business or residential). Any snow or ice that accumulates before noon must be removed by noon that day. If it snows in the afternoon, you have until noon of the next day to remove it. Failure to do so could result in the District having the sidewalk cleaned at your expense. We ask that you use a de-icing "CMA" for sidewalks, please do not use salt as it can cause damage. Please help to keep Summerland's sidewalks safe for all that use them.

SUMMERLAND HEALTH & WELLNESS SERIES - VAPING AWARENESS

On October 8th, the Summerland Health Community Initiative in partnership with District of Summerland, SD 67 and Interior Health held important educational discussions on Vaping. These presentations focused on the health risks of Vaping and how these products are being marketed towards youth. The event included two daytime mini-sessions held at Summerland Secondary School, which attracted over 350 students, and an evening event which was very well received by the community with over 75 attendees and a four-speaker discussion panel. This event was funded by Health Canada - Substance Use and Addictions.

SNOW REMOVAL

Please help our snow removal crew by parking your vehicle(s) off the road. When clearing your driveway, stockpile snow on the right side when facing the road. This prevents the snow you removed from being ploughed back in front of your driveway. Thank you for your cooperation!

WINTER CURBSIDE CART COLLECTION

With winter on its way, many residents are wondering how to use their curbside collection carts. Please:

- Ensure the areas around and under your carts are clear of snow.
- Place carts as close as possible to the road, without obstructing the snow removal operations, street, sidewalk or bike lane.
- Do not place carts behind or on top of a snow bank.
- Ensure there is proper spacing around the carts:
- 1m (3ft) of space on all sides;
- 3m (10ft) of clearance above; and
- 1.5m (5ft) of space from a vehicle.

In the event of a collection delay, please place your cart(s) out each day following the delay until collection can be completed safely.

TAKE YOUR USED MOTOR OIL AND ANTIFREEZE TO THE LANDFILL

Thanks to a Return Collection Facility (RFC) infrastructure grant from the BC Used Oil Management Assoc., a modified Used Oil and Antifreeze RFC is now open and located within the Household Hazardous Waste area of the Summerland Sanitary Landfill. Residential quantities of used oil and antifreeze materials are accepted for no charge when properly returned for recycling in the Used Oil and Antifreeze RFC.
