# Important Information Regarding the March 3rd - 6th Water Shutoff

The water shutoff for the Pressure Reducing Valve #10 (PRV10) project scheduled for March 3<sup>rd</sup>- 6<sup>th</sup> is going forward and final preparations are underway. When the shutoff was announced last fall, the District explained that engineering work was still being reviewed to determine whether the effects of the water shutoff could be minimized.

It is now confirmed that the District will provide an alternative water supply – not drinkable – for the majority of the shutdown. For most properties, this will mean that water will be available through their taps – for showers, flushing toilets, etc. for much of the duration of the shutoff. The water will be diverted from the Garnett Water System and the Summerland Irrigation System and may be intermittent and have low pressure and low flow. **The water will not be drinkable and everyone must still have drinking water on hand.** For about 65 properties that cannot be connected to an alternate system, a water supply will be located nearby.

A pamphlet with complete details about the alternate water supply will be sent to all properties by mid February and information will be printed in the February 23rd edition of the Summerland Review. It will be posted on the District's website and Facebook page. A public information session has also been scheduled as follows:

The Chamber of Commerce is also hosting two sessions for their business members at the Visitor Information Centre. These sessions will be held on February 15, 2017 at 8:00am -9:00am and at 4:30pm -5:30pm. An RSVP is required for the Chamber of Commerce sessions – call 250-494-2686 to confirm your attendance.

Prior to the weekend of the shutdown, a **Boil Water Notice will be in effect**. This will start at 7am on Monday, February 27th as the chlorine from the Water Treatment Plant is reduced to allow the draining of the water more quickly and efficiently. After the work is done, the Boil Water Notice will remain in effect until approval is given by Interior Health Authority that the required standards are back to normal. This could take between 4 to 10 days. It is recommended that residents continue to drink stored water or bottled water during this time frame.

This is a complex project and although every effort is being made to prepare for the work, unexpected situations can occur. Being able to provide our residents and businesses with timely information during the shutdown is critical to the District. We will endeavour to communicate through all means possible. Please remember that the most up to date information will be posted on the District website (www.summerland.ca/watershutoff) and on the District Facebook page. Now is the time to "LIKE" the District to receive ongoing updates as they are available.

### Recycling - Sort it OUT! - Plastic Bags and Overwrap are NOT allowed in Curbside Recycling

Plastic bags and overwrap <u>must not be included</u> in your curbside recycling. Instead, **Collect** them in a plastic bag and **Drop** them at the Summerland Landfill **Recycling** Depot at 17202 Bathville Road, for FREE. These materials cause jams in the recycling machinery and contaminate large batches of recyclicity and contaminate large



and contaminate large batches of recyclable materials, turning them into garbage.

Summerland is under contract with MMBC and must pay fines when incorrect or uncleaned material is included in the curbside recycling. If our residents don't comply...eventually these costs would have to be passed on to you, the taxpayer.

Other items such as glass, Styrofoam, paint cans, computers, small and large appliances and hazardous waste, just to name a few, can also be recycled at the Summerland Landfill but are not permitted in your curbside recycling.
