

Flood Recovery Plan

The water level of Okanagan Lake is continuing to decrease and over the last few days has been decreasing by approximately 2cm per day. The District of Summerland has started to implement recovery efforts although a further decrease is required before all flood protection measures can be removed.



The tiger dam at Powell Beach has been removed and staff have initiated clean up of the area. The beach is open although the ground water in the surrounding area is still high. Rotary Beach, the Pier, and the Boat Launch at Peach Orchard have now been opened. Users are reminded to exercise caution as water levels remain above normal and submerged debris could pose a hazard. The spray park will remain closed until lake levels decrease further as it cannot operate with high ground water.

The process of removing the approximately 200,000 sandbags in place throughout the Summerland waterfront has begun. Property owners are reminded not to distribute sand from sandbags into or adjacent to lakes, streams, ponds, or other water sources. This is

in accordance with the province's Water Sustainability Act. Sand must not be added to beaches.

To assist with the removal of sandbags from private property, residents have three options:

- Filled sandbags may be deposited into large disposal bins located at Peach Orchard Beach Park, Landry Crescent, near the campground at Trout Creek, Powell Beach Park, Wharf St. Beach Access, Nixon Road at North Beach Access, Butler Street near the lift Station, Lakeshore N. beach access and Crescent Beach. The District will empty the bins as they become full.
- Residents may also choose to deposit sandbags in front of their property provided they are not on the roadway or blocking any access to property. If residents choose to leave the sandbags in front of their property, they will be picked up, but it may be a few weeks before crews are available for removal. Anyone who wishes the bags to be taken away immediately should deposit them into the large bins as noted above.
- The District of Summerland is in the process of contracting crews to pick up and remove sandbags from individual properties. Over the next week, a site assessment contractor will visit lakefront properties to determine if assistance is required with the removal of the sandbags. The contractor will estimate the number of bags, note the accessibility of the property and request permission from the owner to access the property for sandbag removal.

Come View the Canada 150 Mural

To celebrate Canada’s 150th, a group of artists set out to create 150 murals representing 150 communities across Canada. In May, Summerland residents painted 310 individual tiles that were put together to form a 9’ x 9’ mural to be displayed as outdoor public art in our community.

Currently, the mural is being displayed inside Municipal Hall on the wall up the stairs from the entrance. A permanent location will be determined by Summerland’s new Cultural Development Committee.

Help the Fight – Recycle Right!

When your recycling is organized correctly, you can be assured it will be properly recycled. When incorrect materials are mixed in or when materials aren’t properly bundled, they can spoil an entire batch, turning what could have been recycled into trash.

Sorting your recycling is an important step to help ensure that materials collected are recycled properly. Proper sorting helps ensure that only materials that can be recycled at a particular facility are collected and sent there. It is wasteful—and dangerous—to transport materials to the wrong place. For example, pressurized cylinders or containers, and aerosol containers with contents remaining can cause fires and explosions in trucks and machinery when they are sent to a facility designed to recycle paper or plastic.

How you organize your materials matters too! Place recyclables loosely in clear or clear blue bags. All items recyclable through the curbside program can be mixed in one bag, other than shredded paper, which must be in a separate securely tied clear plastic bag. Ensure items are empty, dry, and free of debris; remove lids, caps, screw tops, spray pumps, and pull-up tops from containers and place loosely in your recycling bag. Multiple large pieces of flattened cardboard may be bundled together and tied with twine or string and must not exceed 2’ x 3’, no bag required. Main Flushing

The Works Division is performing annual sewer main flushing throughout Summerland from 7:00 am to 3:00 pm, Monday to Friday for the next three months. This annual maintenance ensures that sewer mains are working properly. Please use caution when driving by Crews working on the road. We apologize for any inconvenience and thank you for your cooperation.

Important - Please Water Wisely
 Summerland is currently in Stage 1 but please keep checking the District website as this could change anytime. The hot weather has caused a heavy demand for water.

Although there is still a good supply of water available, the Water Treatment Plant has been operating at maximum capacity. If the high volume continues, additional conservation will be required and the District may be forced to open a supplemental line that could cause a boil water notice to be issued.
