# **FLOODING IN SUMMERLAND**

Since the end of April, Summerland has been faced with flooding due to heavy rain and a higher than usual snowpack. In early spring, high water levels in Aeneas Creek caused local flooding in the Garnet Valley area. Flooding continued throughout May as Okanagan Lake reached levels not seen since the 1990's. The water level has continued to rise into June and has exceeded the all time recorded high reached in 1948. The Province has recently recommended that measures be taken to protect property to the 343.50m level (plus .50 m for wave action). The increase in water level has levelled off over the past two days and the District of Summerland is hopeful, that without a significant rain event or very high temperatures, that the lake level may begin to decline.

Property owners and the District of Summerland have been working very hard to protect homes, structures and municipal infrastructure from the high water. To date, over 140,000 sandbags have been distributed in Summerland.

Some residents in Trout Creek and the Summerland RV Park have had their electricity disconnected as electrical connections have become submerged creating a dangerous situation. Summerland's electrical crew has been able to restore power to most of these properties by reconnecting services above ground. Options are being reviewed to determine whether it will be possible to reconnect the remaining Trout Creek properties before the water recedes.

All District beaches, including the boat launch are closed. The pathway at Landry Crescent, Centennial Trail along Peach Orchard Road and the path from Rotary Beach to the Peach Orchard boat launch are closed due to high water levels. Residents who do not live in the areas affected by the floods are asked to refrain from driving through these areas as traffic has increased and the situation has become dangerous with property owners on the streets working to protect their homes from the rising waters.

District of Summerland crews and the Summerland Fire Department have been assisted by Ministry of Forests fire crews. Many thanks to the individuals, service groups, organizations, and businesses who have come together as a community to help



residents protect their properties from flooding.

Financial assistance through the Province of BC's Disaster Financial Assistance program may be available for property owners affected by the flooding. Residents should contact the program directly to determine their eligibility.

Anyone who has been displaced from their residence because of the flooding are encouraged to contact Summerland's Emergency Support Services at 250-462-0823 for assistance.

# Property Taxes and Home Owner Grants Due 4pm Friday, July 7th, 2017

Property Tax Notices were mailed out at the end of May. Outstanding taxes and Home Owner Grants are due and payable by 4pm on Friday, July 7th, 2017. A 10% penalty will be added to any outstanding balances or unclaimed Home Owner Grants (HOG) after the due date. If this is your principal residence, you may be eligible to claim the HOG. This must be done every year (even if your bank pays the taxes for you).

Payments for property taxes can be made by cheque, cash, debit, post-dated cheque, internet or telephone banking. Please note we do not accept credit cards. Postmarks are not considered as date of payment so don't wait until the last minute!

# Let's Be Clear on Glass Recycling

Glass is an energy intensive material. Making new glass means heating sand and other substances to a temperature of 2,600°F, which requires a lot of energy and produces an enormous amount of industrial pollution. Making recycled glass consumes 40 percent less energy and saves more than a tonne of the raw materials needed to create new glass, including: 1,300 lbs of sand; 410 lbs of soda ash; and 380 lbs of limestone.

In BC, clear or coloured non-deposit jars and bottles <u>must be</u> <u>recycled separately</u> from curbside recycling as glass can easily break during collection and transport. It is difficult to sort broken glass from other mixed recycling, and when broken glass mixes with paper and other containers it becomes difficult to properly recycle these materials. Broken glass is also a safety hazard. **Clear or coloured non-deposit jars and bottles can be dropped off for free at the Summerland Sanitary Landfill** (17202 Bathville Rd).

Plate glass, including glass from windows, picture frames, furniture, and glassware, is <u>not recyclable</u> in Summerland and must be disposed of in your garbage as these types of glass have a different chemical composition and manufacturing process than container glass. Please always wrap broken glass in tape or cardboard for safety reasons.

## **BC Transit Rate Changes**

Effective July 1, 2017 there will be a 25¢ increase in rates for bus trips within Summerland (handyDART now called On Request). A pass will increase from \$2.00 to \$2.25 per trip. Books of 10 can be purchased for \$20.25. Tickets already purchased at the lower rate will be honoured until January 1, 2018.

Regional bus fares will remain unchanged at \$4.00 per trip or 10 for \$36.00.

#### **Signs Not Permitted**

Please be reminded that for safety reasons the District of Summerland does not permit signs to be placed in the roundabouts or on power poles or light standards.

## Plant Smart, Stay Safe

Trees that encroach on overhead power lines are not only the cause of most power outages and disturbances, but they can also pose a serious safety hazard.

If you have a power line on or near your property, it doesn't mean you can't plant trees. The safest bet is to plan ahead so trees won't interfere with power lines no matter how tall they grow.

Here are a few guidelines that will help you ensure your trees won't grow into hazardous trees:

- Trees planted closer than 7.5 metres should be lowgrowing varieties.
- Nothing should be planted closer than 5 metres from the base of a power pole.
- If you have a secondary line connecting your home to a power line, avoid planting trees that will grow into the line. If you don't see a secondary line connected to your house, your secondary line is underground.

Call BC One Call at 1-800-474-6886 or email bconecall.ca at least three working days before planting. Once the utility lines are marked, remember to carefully dig around lines with hand tools.
