2018 General Local Elections

Voting in the upcoming municipal election is important and easy. When you arrive to vote, you will be directed to a table where you will show two pieces of the required ID (see below) and then sign a declaration stating you are eligible to vote (see below). You will be handed a ballot with the names of all the candidates to take to a booth to select up to one Mayor, up to six Councillors and up to two School Trustees. You will fill in the oval beside the names of who you would like to vote for. You can choose up to the number required (or less if you like). After the final

voting day, October 20th, all the ballots will be tallied and preliminary results will be posted that evening. The new council will be sworn in on November 5th.

I.D. Required to Vote

Summerland does not have a voters list and uses voting day registration. At the time of voting you must provide two pieces of ID that must prove who you are and where you live. (i.e. Drivers Licence, utility bill or other bill, Passport, SIN card, Medical Services card, credit or debit card). At least one piece of ID must have your signature on it .

To Qualify to Vote you must be:

- A Canadian citizen
- 18 years or older when registering to vote
- A resident of BC for six months before Voting Day
- A resident of Summerland for at least 30 days immediately preceding Voting Day
- Not otherwise disqualified by law from voting

Voting Opportunities - any eligible voter may vote on any one of these three dates. Choose a day that works for you!

Wednesday, October 10, from 8am - 8pm in Council Chambers at Municipal Hall, 13211 Henry Avenue.

Tuesday, October 16, from 8am - 8pm in Council Chambers at Municipal Hall, 13211 Henry Avenue.

Saturday, October 20, from 8am - 8pm at Giant's Head Elementary School and Summerland Senior High School.

Persons that own property in Summerland for at least 30 days before Voting Day, but do not reside in Summerland may be eligible to vote as Non-Resident Electors with restrictions. Union of BC Municipalities (UBCM)

Mayor and council had a productive week at the recent annual UBCM conference. Council met with five provincial cabinet ministers as well as senior ministry staff to discuss topics related to Summerland, and they also spent time on an

informal basis with the Premier and other ministers discussing Summerland initiatives. Council attended various educational sessions and heard different perspectives on challenges municipalities currently face including affordable housing, policing in BC, cannabis legalization, community resiliency (fire & flood prevention), homelessness, revitalization of the ALR and

Council met with Emergency Management BC (EMBC) and Forests, Lands and Natural Resource Operations (FLNRO). The meeting focused on the need for the province and municipality to work closely together in the development of funding policies during emergency response. Summerland had an additional meeting with FLNRO to discuss Eneas Creek and the critical need for the province and municipality to work together with property owners to assist with mitigation and recovery efforts along the creek and to provide greater assistance to property owners affected by emergency events.

At a meeting with the Minister of Agriculture, council emphasized the municipality's readiness to locate a regional Okanagan Agricultural Innovation Centre in Summerland and requested funding support from the province.

An extension of the Lakeshore pathway from Trout Creek to Penticton was discussed with the Minister of Transportation and Infrastructure. Council urged the Minister to consider such a project critical for the safety of those cycling on the highway.

Lastly, council met with the Minister from Municipal Affairs and Housing to thank the ministry for the funding support on recent infrastructure projects. They also requested that the current application for funding (Flume and Water Treatment Plant Intake upgrades) be approved.

Open Burning Permits are issued from October 15 to April 15 to owners of agricultural properties with over two acres for the purpose of burning orchard prunings and stumps. Permits are issued by the Fire Department.

Those with permits are required to call the Fire Department at 250-494-7211 to check the venting index and obtain approval each time they burn. **Open burning on residential properties is strictly prohibited.**



Free Run for Dogs

From October until the end of April, dogs are allowed to be off their leashes on the grassed area at Peach Orchard Park. Dogs must remain leashed on the walkway or playground. Please continue to be considerate of others by following the signage and picking up after your pets.

Garbage/Recycling/Yard Waste Carts

It is important to remember to properly space your carts for collection.

Please ensure there is a minimum:

- 1m (3ft) of space on all sides of each cart;
- 3m (10ft) of clearance above your carts; and
- 1.5m (5ft) of space between the carts and vehicles.

Need a Different Cart Size?

If a different size of cart(s) would better suit your household needs, you can make changes. All three carts are available in the following sizes: 120L or 240L or 360L. You can also change your garbage cart to a 120L wildlife resistant garbage cart and/ or have your yard & garden waste cart removed.

Until **December 31, 2018**, residents may change the sizes of any number of carts, **one time**, without paying the switch-out administration fee (\$30). Please note that requests for certain changes may incur other fees (such as upsizing garbage carts). Trail Construction on Giant's Head Mountain

The District of Summerland supports a vibrant and liveable community by providing access

to recreational

amenities. Expect to see activity on Giant's Head Mountain as construction of Phases 1 and 2 of the Trails Redevelopment Plan starts this



fall and will be completed in the spring. These first two phases include trail improvements, trail decommissioning for erosion control, a new multi-use trail, improved guard rails, and park entrance improvements. This District of Summerland trails project, in partnership with the Rotary Club of Summerland, was planned in consultation with the community, user groups, and stakeholder groups with the goal of building a trail infrastructure system which meets both recreational and environmental needs over the next ten years. This project received \$435,000 in funding from the BC Rural Dividend Fund.
