1 INTRODUCTION

1.1 PURPOSE & KEY GOALS

The District of Summerland has identified the need for the replacement of the Summerland Aquatic & Fitness Centre and are exploring the inclusion of a Primary Care Health Centre as one of Council's Strategic Priorities. A robust public engagement program was included to provide a summary of community needs and priorities for recreation and health services and their associated spaces. The results in this report serve as an important first step towards the goal of replacing the Summerland Aquatic & Fitness Centre. They also identify community priorities for other community services and facilities that could be co-located with a new Community Recreation Centre.

During the development of the study, residents, facility users, and stakeholders could provide input on:

- The community's **vision for the project**;
- The community's **needs** for aquatics, indoor recreation, health care services, wellness services, and other services for children, seniors, and youth, as any **barriers to accessing** these services;
- **Partnership opportunities** within the community and stakeholders, and
- **How to pay for new facilities**.

The engagement program includes two rounds of engagement:

1. Exploration of community needs and priorities (included in this summary)
2. Community review the Engagement Summary and the Draft Needs Assessment (to be completed in late fall)

1.2 ENGAGEMENT ACTIVITIES & PARTICIPATION

The following engagement activities were completed as part of the community engagement process.

1.2.1 PUBLIC ENGAGEMENT

An **online survey** was available on the District of Summerland's website from September 15th to October 4th and gathered **620 responses** from members of the public. Detailed results are available in **Appendix A**.

The District also hosted an online **Open House** on September 24th from 4:00 to 7:00pm. A total of **20 people** participated. The Open House took place on Zoom and included opportunities for participants to ask questions and share feedback and concern with the consulting team and District of Summerland staff. Feedback was captured during the open house using an online whiteboard (MURAL).

Feedback, discussion topics, and questions from the Open House are provided in **Appendix B**.

1.2.2 STAKEHOLDER ENGAGEMENT

Stakeholders were identified by District of Summerland staff and the project Steering Committee, as well as the consulting team. Stakeholders were invited to complete a **stakeholder questionnaire** to provide information about their organization, future needs, potential partnerships, and understanding of their membership's preferences for how to pay for a new facility. The results from the stakeholder questionnaire are summarized in **Appendix C**.

The project team also hosted **stakeholder workshops** with the **Parks and Recreation Commission** and **stakeholders** from a range of user groups. These included:

- Parks and Recreation Commission Workshop – August 24th – 8 members
- Community Organizations Workshop – August 25th – 7 participants
- Aquatics and Recreation Organizations Workshop – August 25th – 6 participants
- Medical Stakeholders Workshop – September 23rd – 4 participants

Feedback from these stakeholder workshops was captured using an online whiteboard and is provided in **Appendix D**.

1.2.3 PENTICTON INDIAN BAND

The District initiated engagement with the Penticton Indian Band and had an initial meeting with PIB staff. Information was provided including the project background, process and overview. PIB confirmed the importance of the location and context of the future facility and expressed interest in exploring the project's relevance and importance to PIB Council, elders, and members and potential opportunities. How further engagement will proceed is an ongoing process and discussion with PIB.

1.3 PUBLICITY & OUTREACH

1.3.1 PROJECT WEBPAGE

The District of Summerland created a project webpage that included an overview of the project, key dates, engagement opportunities, and other relevant information. The online survey was promoted through social media and was available on the project webpage.

1.3.2 SOCIAL MEDIA

In addition to advertising the online survey, links to the **project website** and invitations to **engagement events** were posted on the District's social media platforms of Facebook and Twitter during the month of September.

1.3.3 EMAIL NOTICES

A stakeholder list was created from existing contact information of community organizations, interest groups, partner organizations, and other organizations. This list included **108 stakeholder organizations** and was used to provide notices about the project, links to the project webpage and online survey, and to encourage attendance at the open houses. Helping spread the word about the project and opportunities to participate was also encouraged.

The District of Summerland also established a project email list of anyone who wanted to receive updates.

1.3.4 OTHER OUTREACH

Engagement opportunities were also promoted through the District of Summerland's Monthly Utility newsletter, with 5,900 printed and digital each month.

2 RESULTS

The following sections describe the key results by topic, pulling together the results from each engagement activity. Full details on the results of individual engagement activities are provided in Appendices A, B, C, and D.

2.1 INDOOR RECREATION & COMMUNITY SERVICES

2.1.1 VISION

The **public online survey** and **stakeholder questionnaire** asked what best describes respondents' hopes for an aquatics and indoor recreation facility in Summerland. In the **stakeholder workshops**, we also asked for key vision words.

- The community vision for aquatics and indoor recreation from the survey, stakeholder questionnaire, stakeholder workshops, and open house are captured, roughly in order of importance, in the following categories. Overlapping vision words and terms included within each category are listed under each category.
 1. **Be inclusive and welcoming of all people, ages and abilities**
 - Inclusive, All ages, Accessible, Multigenerational, Affordable
 2. **Encourage active lifestyles**
 - Wellness for Life, Facilitating activity, Recreation = Health, Empower people through recreation, promote active and healthy living
 3. **Be flexible to meet community needs over time**
 - Multifunctional, Multipurpose, Flexible, Adaptable to community needs
 4. **Create a central community hub**
 - Centralization, Central Hub for the community, Core Hub, Complete, Central and Connected, One Stop Shop, Convenient, Together
 5. **Bring positive economic benefits**
 - Economic opportunities, catalyst for downtown, holistic cost-benefits, practical
 6. **A high quality facility**
 - Be something our community takes pride in, Engaging, Unique, Innovative, Modern, Sustainable and Green
- Within the public survey, the lowest priorities were:
 7. **Being a cultural and arts space** and
 8. **Being a regional draw.**

- Select survey responses highlighting the potential of a new community centre:
 1. *“I feel that a recreation centre that provides services across the age spectrum makes us a healthier community and will help make Summerland a place to bring up kids, provide healthy opportunities for our youth, adults, and seniors.”*
 2. *“It promotes a healthy lifestyle which promotes a healthier community.”*

2.1.2 AQUATICS

- In the **public survey**, we asked what **indoor recreation spaces were missing or in need of expansion** in Summerland. **Aquatics** was the number one response (68%).
 1. Regarding what **amenities and options** were most important to provide in a new pool, there was strong support for:
 - A fun place for kids and families,
 - Leisure swimming, and
 - A hot tub.
 - *“Having a pool is very important for quality of life here in Summerland.”*
- The Orca Swim Club, aquatic fitness users, rehabilitation users, and lap swim/recreation users were identified as **key stakeholders for aquatic services** due to their frequent use of the pool. These stakeholders have specific facility needs in order to deliver their programs and meet the demand for these activities in the community. The **following features** had **broad agreement**:
 1. In line with the key vision themes, there was support for improved **accessibility, aquatic access** options, **inclusive change rooms** and **family change room** options.
 2. It was highlighted that aquafit and rehabilitation programs need **a variety of depths** to serve the range of abilities of those who participate. Aquatic fitness and rehabilitation programs such as aquafit and recope are an important opportunity for seniors and those recovering from injuries or other health issues to stay active and healthy.
 3. A **6 to 8 lane pool** (8 preferred) that meets the requirements for **hosting swim competitions**. Swim meets are an important part of the swim club experience and also helps raise funds for the club. Additional detailed needs were submitted by the swim club.
 4. **More than one pool with different temperatures** – cooler for swim club and lap swim; warmer for rehabilitation, swim lessons, and leisure swimming. Among write-in responses to the public survey, the most common request was for separate temperature pools for laps (cool) and leisure swimming/rehabilitation uses.

- *“I am a mom here, and most of the other mothers recommended to me to ‘Bring your kids to swim in Penticton because it is so much warmer and more enjoyable’. I heard it over and over again when I first moved to Summerland a few years ago.”*

- In the **public survey**, a **sauna** and a **steam room** were the **least important amenities**. While these amenities were mentioned by two respondents in the stakeholder questionnaire, they were not mentioned in the stakeholder engagement or public open house. This places them as a lower priority.
- The need for **improving aquatic facilities** in Summerland is also supported by multiple mentions of the need for **more indoor activities** in the winter and **more activities for families with young children**. Pools also provide a low-impact exercise option, which can help address the needs of the aging population.

2.1.3 GYMNASIUM

- Addition feedback about what **indoor recreation spaces were missing or in need of expansion** in Summerland speak to the need for a gymnasium and a fitness centre (discussed in section 2.14). **Space for gymnasium sports** (basketball, volleyball, pickleball, badminton, etc.) was in the third most frequent response (51%) after **aquatics** and a **workout/fitness centre**. This is further reinforced through the survey responses asking what indoor recreation and community use spaces are most important, with gymnasium ranking third (3.7 out of 5) after fitness centre and fitness program spaces.
- Through multiple engagement methods, it was identified that there is currently unmet demand for **gymnasium space**.
 1. **Public online survey**: Access to **gymnasium space** was rated as **poor or very poor** by 41% respondents. Only 10% said gymnasium access was good or very good.
 2. **Unmet demand for gymnasium space** was also highlighted in the **stakeholder survey**, **stakeholder workshops** and the **public open house**, particularly in relation to pickleball, volleyball, and basketball, as well as the opportunity for hosting events, drop-in programs, providing opportunities for families and youth, and providing more activities during the winter.
 3. **School District 67** has indicated that the school gymnasium is currently in use from 7:30am to 9:30pm during the school year, offering minimal opportunity for community access.
- Along with the identified demand, there was **moderate support** for a **dedicated community gymnasium**. A variety of organizations **voiced support** in the **stakeholder survey** and **stakeholder workshops**, including community organizations, health care providers, and recreation groups. Some who were hesitant to support a dedicated community gymnasium suggested that additional access to the school gymnasium may meet existing needs. Stronger support may emerge if, consistent with indications of SD 67, no additional access was realistically available at the school gymnasium or other community facilities.

2.1.4 OTHER INDOOR RECREATION

Fitness facilities, spaces for **families/children/youth**, and **multipurpose rooms** were all noted as important to the community. Stakeholders highlighted the lack of facility space (58%) and problems with facility design (42%) as factors limiting their organizations from serving more community members.

- **Fitness facilities:** Facilities for fitness, working out, and taking fitness classes topped the list in the public online survey.
 1. **A fitness centre** (i.e. workout space with weights and cardio machines) was the second most frequent response for what is missing or in need of expansion (55%) and was ranked highest in importance (4.3 out of 5).
 2. **Fitness programs** were less frequently selected for what is missing or need of expansion (43%), but was ranked second in importance among indoor recreation facilities (4.0 out of 5) after a fitness/workout centre.
 3. The **need for fitness facilities** was less of a priority in the **stakeholders questionnaire** or **stakeholder workshops**, but was still mentioned in every session. There is overlap with health and wellness program space, which was strongly supported by stakeholders in the workshops.
- **Families/Children/Youth:** Family and young child (infant-preschool) drop-in programs were highlighted as a strong need across all engagement methods. Stakeholders noted the need for spaces and programs for children and youth both in the stakeholder questionnaire and workshops. Please see section 2.1.5 for further discussion of community services related to families, children, and youth.
 1. **Youth-oriented programs** were noted by 49% as missing or need expanding and youth drop-in space ranked a close 4th in importance (3.6 out of 5) after fitness centre, fitness program space, and gymnasium in the public online survey. Youth services was the top priority for community services to be included in a recreation centre (60%), over and above childcare (53%) and seniors services (40%). The Boys and Girls Club mentioned that they see a very significant demand for youth programs and services and do not have adequate space to meet that demand.
 - *“I have youth and a place to hang out and meet that is safe and fun is always needed”*
 2. **Childminding** (drop-in childcare when parents or guardians are participating in classes or programs) (42%), **Family and child-oriented programs** (38%), **Childcare/daycare programs** (36%) were noted as missing or in need of expansion; Childminding was ranked a close 4th in importance and tied with youth drop-in space (3.6 out of 5); Drop-in for child and family activities ranked a close 5th (3.4 out of 5). Stakeholders noted the need for family and infant/toddler drop-in programs and daycare/out-of-school care in the stakeholder questionnaire.

- *“There is a definite shortage of daycare for young children here - also since SADI closed, [there is] a lack of youth programming other than the church.”*
- **Multipurpose room:** While multipurpose rooms had lower levels of interest than the spaces above, the support is important, particularly due to its overlap with the demand for spaces for children, youth, and seniors programming and drop-in.
 1. The greatest need was for **medium sized rooms** (sized for 11 to 30 people) for meetings, programs, classes, events ranked 8th (3.3 out of 5). The room sizes that ranked lower included smaller rooms (10 people or fewer) (2.9 out of 5); large rooms (31-80 people) (2.8 out of 5); and banquet room (81 people or more)(2.5 out of 5).
 2. Stakeholders noted the need for **meeting rooms, classrooms, event spaces, and community gathering and social areas**. In the stakeholder questionnaire, 4 of 18 organizations mentioned the need for meeting rooms and educational spaces. The existing Resource Centre was noted as already providing space for 16 community organizations. Rooms at a recreation centre should compliment and not replace the Resource Centre.
- **Indoor racquet sport courts:** It is clear there are two significant user groups interested in improved and expanded facilities, pickleball and tennis. Overall, these activities received lower interest and support throughout the engagement activities compared to aquatics, fitness, gymnasium space, and programs/facilities for children, youth, and families. Where these activities can be delivered in multipurpose facilities, there is local demand for both activities and potential for growth and increased participation.
 1. **Indoor tennis** was mentioned numerous times with comments, especially regarding how it would enable more year-round use, be a regional draw, that it could be multipurpose, and highlighting the existing popularity and growth. However, overall, it had lower support than most other spaces. Indoor tennis was lowest on the list of facilities that are missing or in need of expansion in Summerland (17%). It was also ranked last in the priorities for indoor recreation and community use facilities in the public survey (2.3 out of 5).
 2. Support for **indoor tennis** was heard from the Lakeshore Raquet Club in the **stakeholder questionnaire** and **workshop**, but did not elicit strong support from other stakeholders. The tennis club supported exploring how an indoor tennis facility could be multifunctional. There is potential overlap with the demand for pickleball, for example, as both can use the same court space for recreational (rather than competition) courts. While new glass flooring options with LED line markings could allow courts to be used for both tennis and pickleball competitions, wide demand for a competition level facility has not been demonstrated, particularly given the high cost of glass flooring.

3. There was enthusiasm for **pickleball** among survey respondents, particularly in the write-in answers to the **public online survey**. However, as with tennis, when ranked against other indoor recreation priorities, it scored neared the bottom of the list of priorities for indoor recreation and community use facilities (2.7 out of 5). It should be noted that pickleball could be accommodated in a gymnasium or on shared-use tennis courts.
- **Indoor walking track:** The idea of an indoor walking track came up during multiple engagement activities. It was written into the **public online survey** as one of the facilities missing in Summerland and was ranked equivalent to youth drop-in and drop-in childminding as a priority for indoor recreation (3.6 out of 5). It was also mentioned in the **stakeholder questionnaire, stakeholder workshops, and public open house**.

2.1.5 OTHER COMMUNITY SERVICES

- There is unmet demand for **youth programs/spaces, childcare, and seniors programs/spaces** indicated in all the engagement activities. The needs of families, children, and youth are highlighted in the previous section.
 1. **Public online survey top priorities:**
 1. **Youth services/dedicated youth space** (60%)
 2. **Childcare/daycare** for 0 to 5-years old (53%)
 3. **Seniors services/dedicated seniors' space** (40%)
 2. Stakeholders such as the Boys and Girls Club noted that there is strong demand for **additional youth spaces** and programs.
- Spaces that allow people to **meet basic needs** (i.e. hygiene, showers, food) and serving new Canadians were also mentioned in the stakeholder workshops as growing needs.
- It was highlighted in the stakeholder workshops that there are already **arts and culture, dance studios, and community kitchens in the community**. It was suggested that a review of existing community kitchens could help determine if they are being fully utilized and meeting demand. There may be design features that are missing in terms of providing nutrition and cooking classes.

2.1.6 WILLINGNESS TO PAY FOR INDOOR RECREATION & AQUATICS

- There is **strong support** in the community for replacing the existing Aquatic and Fitness Centre and a willingness to pay including through the following:
 - Public online survey: 83% strongly support, 10% somewhat support.
 - Stakeholder survey: 75% strongly favor, 13% somewhat favor.
 - There was also support voiced in **stakeholder workshops** and **public open house**.
- **Reasons for support included:**
 - Supporting community health and wellbeing for a wide range of people.
 - Summerland needs to have these facilities, programs, and services in the community (i.e. not rely on Penticton or other facilities in the region).
 - It would attract residents and families to the community.
 - The existing facilities are undersized and in need of replacement.
- **Reasons for not supporting included:**
 - Facilities in Penticton are close enough.
 - Not wanting tax increases.
 - There are other priorities, such as roads and utilities.
- We heard a number of perspectives about whether Summerland should have its own services or rely on neighbouring communities.
 - In **stakeholder workshops**, many clearly highlighted that driving out of the community, to Penticton or elsewhere, for recreation is a **significant barrier** to participation for those most in need of access to programs and services to maintain health and well-being.
 - 17 write-ins to the public online survey argued that **Summerland needs its own facilities**.
 - *"We need facilities in Summerland to encourage community engagement. The more we have to go elsewhere to find services, the less time we have to engage and contribute to our community."*
 - *"At this time, we feel drawn to use Penticton so facilities, our little town is crumbling."*
 - *"It's essential for people to want to live in Summerland to have these types of programs. Otherwise it's a constant drive to Penticton and might as well move there."*

- *“Recreation is a vital part of a healthy happy community. I want Summerland to remain an independent community and not a bedroom for Penticton”*
- 4 write-ins argued that facilities in Penticton are close enough and that Summerland’s needs can be met by **facilities in neighbouring communities**.
 - *“Penticton Community centre is 20 minutes away and that is normal for any Canadian centre.”*

2.2 PRIMARY CARE & ALLIED HEALTH SERVICES

2.2.1 VISION

In the **public online survey** and **stakeholder questionnaire**, we asked what best describes your hopes for Primary Health Care, medical and wellness services in Summerland. We also asked for key vision words in the **stakeholder workshops**.

- The top three answers from the **public survey** were (from multiple choice list):
 1. Timely access to medical services,
 2. Convenient access to walk-in clinic for minor medical problems in Summerland, and
 3. Every Summerland resident has a family doctor or nurse practitioner based in Summerland.
- Slightly lower but still ranked very high in importance were
 4. Access to a wide variety of healthcare and wellness services in Summerland, and
 5. Convenient location.
- In the **stakeholder questionnaire**, the top three answers were (open ended answers)
 1. More access (9/20)
 2. Multi-disciplinary (5/20)
 3. Comprehensive services (5/20)
- In the **stakeholder workshops**, the vision discussion focused on how bringing together different services and practitioners would benefit patients as well as those delivering the services. Many felt it would help attract and retain physicians. The key concepts discussed were:
 1. Benefits of centralization,
 2. Overall benefits to community health, and
 3. Importance of coordination, collaboration, and partnerships.

2.2.2 NEEDS & BARRIERS TO ACCESS

In the **public online survey and the stakeholder workshops**, we asked about access and barriers to healthcare service in Summerland. We included consideration of family doctors nurse practitioners, as well as allied health, wellness, and specialized services.

- Across the board, **access rated poorly**. For each category, the weighted averages of responses fell between “poor” and “fair”, with none of the weighted averages showing as “neutral”, “good”, or “excellent”.
- **Access was rated the lowest** for the following:
 - Access to Programs & services for those with learning challenges (1.92)
 - Mental health services (1.99)
 - Programs and services for those with mental disabilities (2.01)
- **Access** to allied health and care professionals (2.99), diagnostic medical labs and testing (2.85), and health services for seniors (2.85) was rated higher than access to **primary care providers** (2.82)
- Most respondents said they and their close family do not experience **barriers to access** (71%). Of those who said they do experience barriers (29%), the most significant barriers to access were:
 1. Finding a practice that is **accepting new patients** (4.5),
 2. Finding access to **walk-in services** (3.9), and
 3. Getting a **doctor’s appointment** when I need it (3.9).
- Less significant barriers were:
 1. Accessing **public transit** (2.9),
 2. Finding **parking** (2.4),
 3. Getting to a **lab or pharmacy** after visiting doctor (2.3), and
 4. **Driving** downtown (1.8).
- The stakeholder workshop discussions verified that there are an estimated **3,000** Summerland residents who **do not have a family doctor**.
- Interior Health verified that there is currently demand for at least **one dedicated mental health practitioner** in Summerland.
- Multiple stakeholders highlighted the lack of **temporary offices** for seeing patients and completing documentation for practitioners who travel to Summerland on an occasional

basis. The **lack of office space** was also highlighted as an issue at the Summerland Health Centre.

- Stakeholders highlighted that those who are most in need are **most affected by the barriers** to access such as travel to other communities, lack of a centralized location, and awareness of services. **Travel to Penticton was mentioned as a barrier** for seniors and in relation to accessing mental health services.
- Comments in the **public online survey** included the following quotes:
 1. *“I have always been referred to programs in Penticton for issues like chronic pain. I don’t know if it’s reasonable to expect a small community to provide everything, but it would be nice.”*
 2. *“Took me 3 years to find a family doctor in West Bank now, have to drive, brutal.”*
 3. *“Family doctor retired, can’t find a replacement.”*

2.2.3 BENEFITS OF INCLUDING A HEALTH CENTRE WITH THE RECREATION CENTRE

Through the engagement activities, we explored the **potential benefits of locating a primary care health clinic with a community recreation centre.**

- Most respondents to the **public online survey** felt there are **benefits to locating a primary healthcare clinic and a recreation centre together** (55%).
 - Those in agreement cited:
 - **Connections to physiotherapy or rehabilitation** (21 comments),
 - **Reinforcing the link between physical activity and health** (10),
 - **The appeal of a centralized facility** (8), and/or
 - **Having better access to a range of services** and healthcare providers (7).
 - We also explored this question with **stakeholders**. Stakeholders noted benefits including:
 1. Destigmatizing **mental health services**;
 2. Better **transitions from health services** to rehabilitation and community wellness programs;
 3. Potential **improved communication** between healthcare providers and other community services; and
 4. **Improved awareness** of the health services available in Summerland.
- It is important to note that **priorities associated with co-location** (“Having these services under one roof” and “Collaboration with recreation centre”) ranked relatively low, suggesting that there is not consensus amongst the public on this approach. Priorities associated with co-location ranked lower than each of the following:
 - **Timely access to medical services,**
 - **Convenient walk-in clinic, and**
 - **Ensuring access to family doctors for all Summerland residents.**
- Some of the comments from the public online survey in **support of co-location** noted the importance of a holistic approach:
 1. *“I think it sends a positive message that correlates activity with health”*
 2. *“If this community had an all-encompassing health, fitness, community hub I would go so much more often.”*
 3. *“A centre that is a holistic hub for wellness makes sense. If people can access medical, rehabilitation, and fitness services under one roof, I think mental health will improve as well.”*

- Some comments **supported co-location** with a health and wellness centre geared to **rehabilitation** rather than primary care.
 - 1. *“The best use of the new Center would be for rehab services and the health professionals that deliver that service. Nurse for RECOPE support. PT/OT for Program delivery. IHA programs such as cardiac rehab. These are the professionals that will actually use the facility. Accommodating Drs and NPs is the wrong direction”*
- Comments from those who **oppose co-location** felt that:
 - 1. Existing facilities are adequate (12 comments) and/or
 - 2. The physical connection between health services and a recreation centre is not necessary (10).
 - *“I do not think they belong together. We have troubles getting doctors to come here and there enough spaces for them to practice.”*
 - *“Summerland already has a bunch of healthcare clinics that are quite close to the pool area currently, so I do not think it would be necessary.”*
- **Other concerns** included:
 - 1. A sense that the lack of doctors was a more important limiting factor than the lack of healthcare clinic spaces (5), and
 - 2. Co-location may put rec centre users at risk of exposure to contagious diseases (5).

2.2.4 WILLINGNESS TO PAY FOR PRIMARY CARE HEALTH CENTRE

There is **cautious support** for a primary care centre, and recognition of the need for improvements to health care access. However, there were more people answering “don’t know” and “not sure”, as well as many concerns and questions.

- **Public Online Survey:** 23% support significant District taxpayer funding; 37% support moderate District taxpayer funding; 20% opposed to any or limited District funding; Stakeholder Survey: 50% strongly support District investment as part of a joint project/partnership;).
 1. Supporters cited the need for services in Summerland (4), especially given its aging population (3).
 - *A representative comment was: “No one should go without access to a regular Dr, especially in a retirement town where medical history is substantive and important for Dr to know.”*
 2. Those who did not support this initiative expressed concern about the DoS funding healthcare, which is traditionally a Provincial responsibility (8), and usually provided by for-profit entities at the primary care level (9).
 3. Other responses cited the need for additional information to form an opinion, particularly around funding models, partnerships, funding availability, and tax implications. Many concerns around the cost, additional tax burden, and affordability, particularly for seniors and low-income people. Some felt existing services are sufficient.
- Similar questions arose with stakeholders. Some saw potential, while some saw no benefits of a physically connected space. Most were curious about what the **partnership, business, and funding models** would look like. Stakeholders highlighted the potential for funding from four different provincial agencies if a **strong partnership model** could be established.
- There were also 12 open comments (Q.16) expressing **support for aquatics and recreation, but not a primary healthcare clinic**.
 1. *“Summerland needs a new aquatic recreation centre. It is vital for the community. The facility should have an up to date pool along with an indoor walking track, a fitness area and community space for programs. It should be a place for all people, not specific community groups. Space should be flexible to accommodate programs for families, youth and seniors. Trying to put healthcare and community services within a recreation facility is a big stretch and it would be awful to see the project not go ahead because the projects weren't compatible...”*
 2. *“The current pool/recreation centre is outdated, too small. I support this investment. I don't think a health centre component is necessary though. There are enough spaces in the small community for the health services to be offered, I don't think they need to be moved/collocated.”*

3 CONCLUSIONS

3.1 RECREATION CENTRE

3.1.1 CORE RECREATION CENTRE USES

Across the breadth of the engagement responses and discussions, the following themes emerged as most important for the core recreation centre uses:

- **Aquatic centre** – Replacement and improvement of the aquatic centre is the highest priority of the community. There is demand for a larger pool, more than one pool, a hot tub, and better accessibility. A new pool should accommodate swim competitions, consider proximity of multipurpose rooms to support swim club and rehabilitation programs.
- **Fitness centre** – Replacement of the fitness centre (workout space, cardio machines, and weights) is very important to the community. This facility is further supported by the importance of programs for seniors, rehabilitation programs, and the vision of a facility that supports community health and wellness.
- **Gymnasium** – There is demand for gymnasium space and this is further supported by demand for indoor activities for all ages in fall/winter/spring; event and community gathering space; programs and drop-in for children, youth and families; pickleball; volleyball; basketball; and childcare (could host summer camps). It was noted in the comments that Summerland is the largest community without a community gymnasium. It is unlikely that the School District could meet all the demand for gymnasium space, particularly as the community grows over the next 40-50 years.
- **Fitness program space** – Fitness program space is high on the list of important facilities for indoor recreation. Further support includes the vision for community health and wellness; programs and services for seniors; demand for rehabilitation programs; and demand for dry land training and space for swimmers.
- **Multipurpose rooms** for classes, programs, and meetings.

3.1.2 OTHER COMMUNITY SERVICES

When considering additional community services that could be located within the community centre, the following needs emerged. While they are listed from more prominent to less prominent, it should be noted that there may be additional demand for seniors' services given the lower representation of survey respondents 75 years and older.

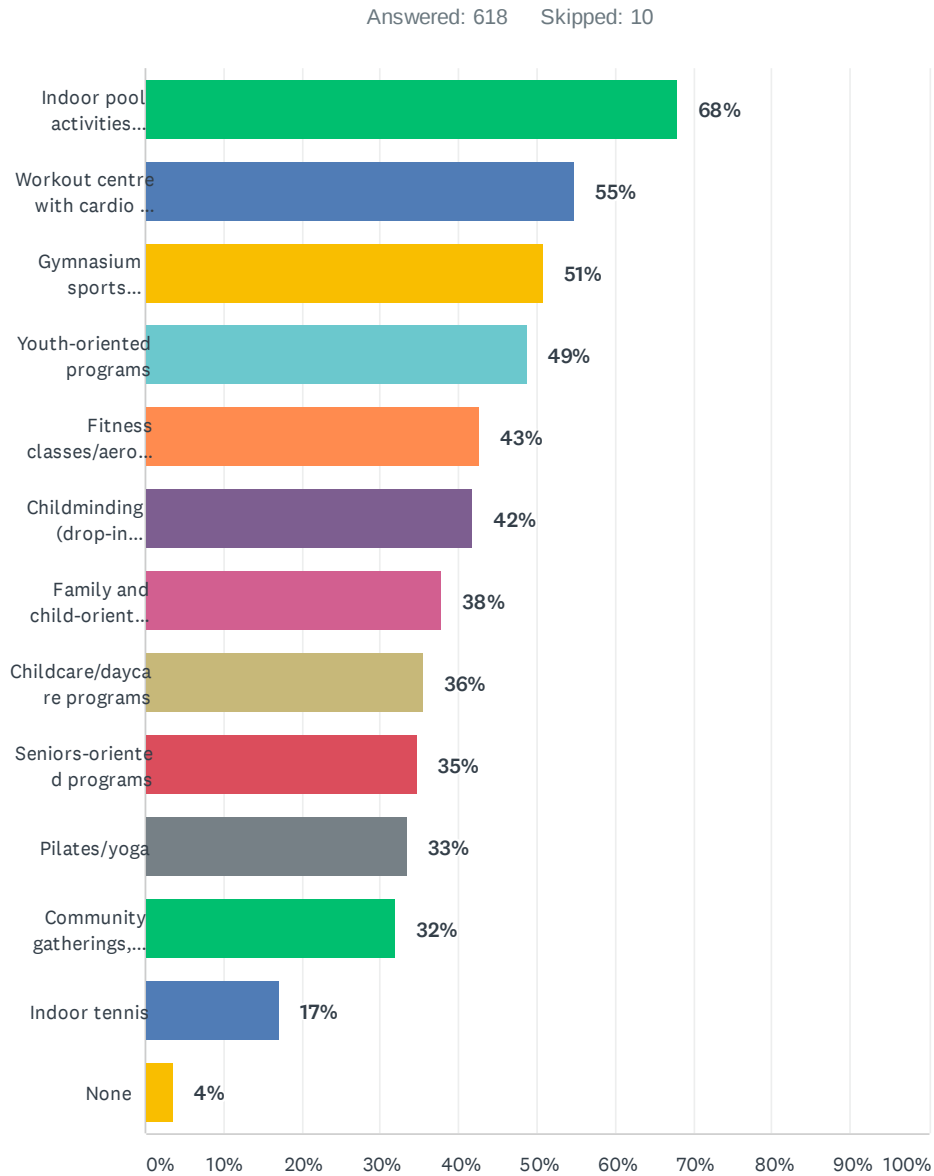
1. **Youth programs** and/or dedicated youth spaces
2. **Childcare/daycare** for children up to 5 years old
3. **Seniors' services** and/or dedicated seniors' spaces

3.2 PRIMARY CARE HEALTH CLINIC

- There is a demonstrated need for better access to family doctors, timely and convenient walk-in health services, and space for dedicated mental health professionals (Interior Health).
- The main benefits of investing in a health clinic focused on having better access and more coordinated care, improved awareness of health services, improved access by centralizing key health services, and reducing the barrier of having to travel to Penticton for essential health care.
- There was an indication that the community sees potential benefits of co-locating healthcare services with a recreation centre, but there were many questions and concerns that are preventing strong support and willingness to pay by the community. Further clarification of the partnership model, funding, and tax implications is needed before clear direction from the community can be established. With 29% of respondents to the public online survey answering “neutral” to the question of willingness to pay, it is likely that greater cost to tax payers would mean lower support.

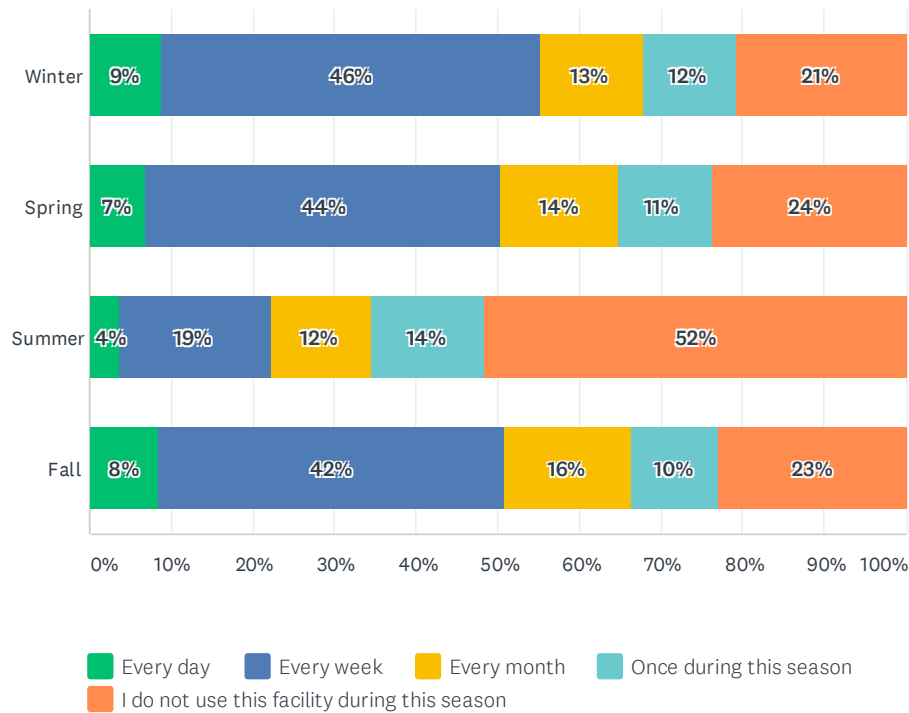

Q2 How often do you typically use the Summerland Aquatics & Fitness Centre?

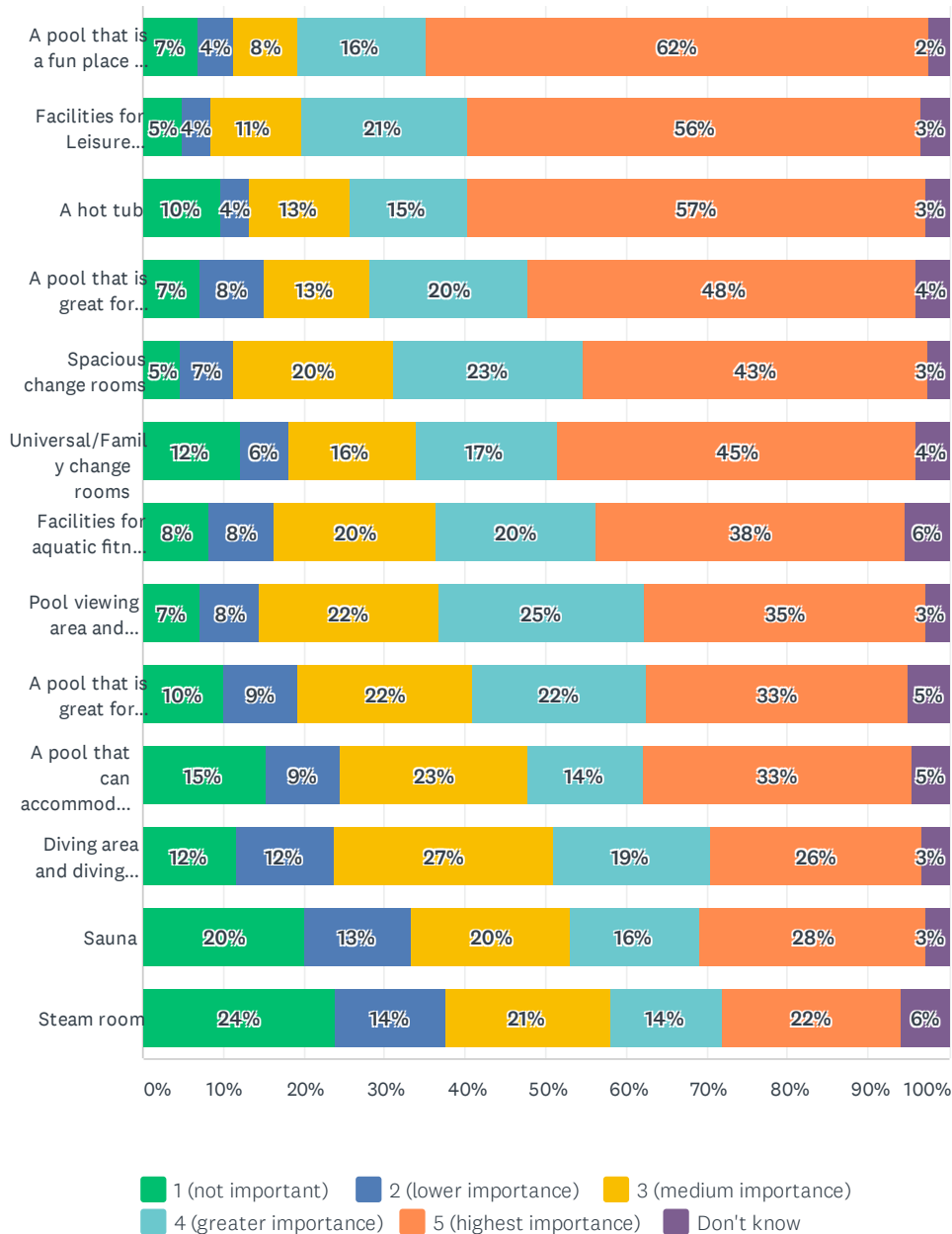

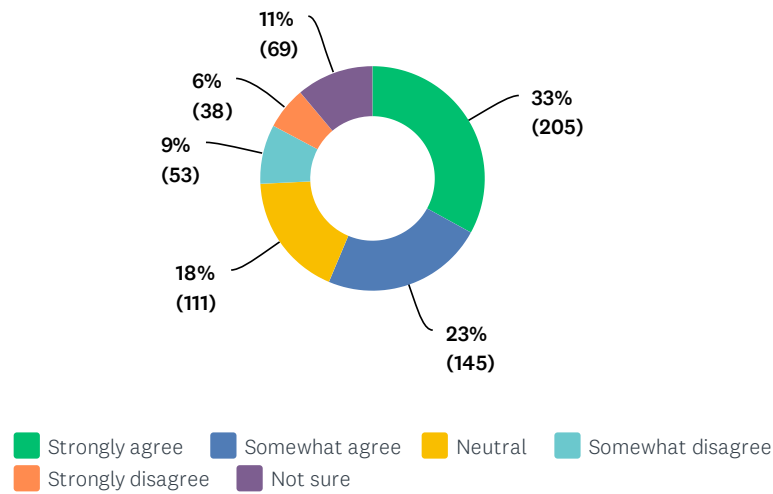

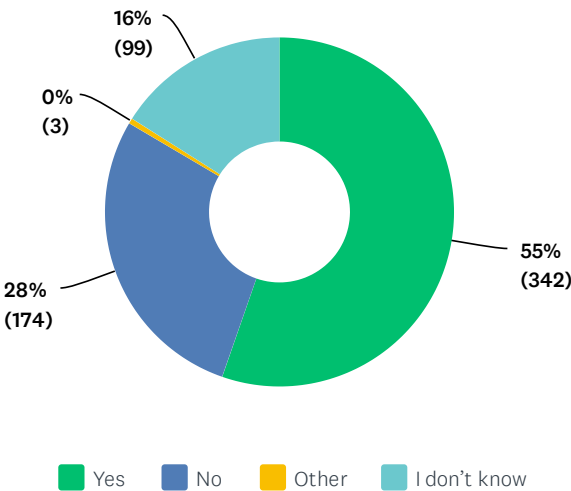

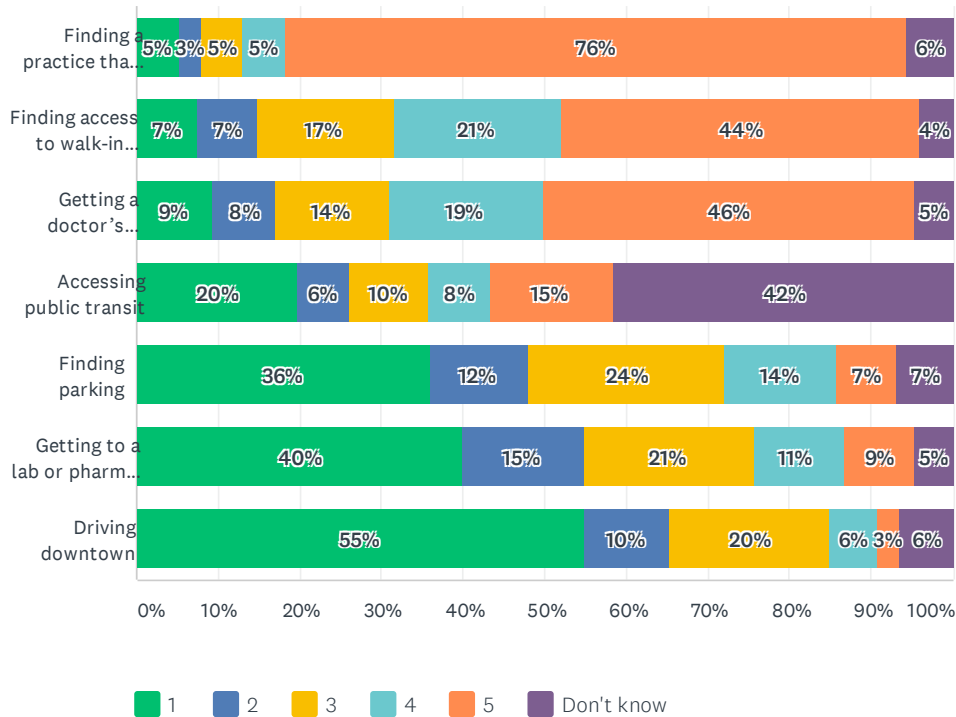

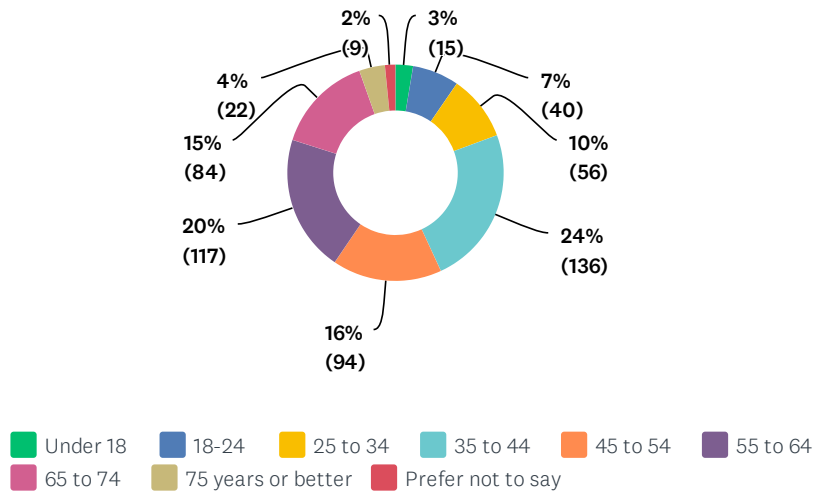

Q18 Into which of the following age category do you belong?

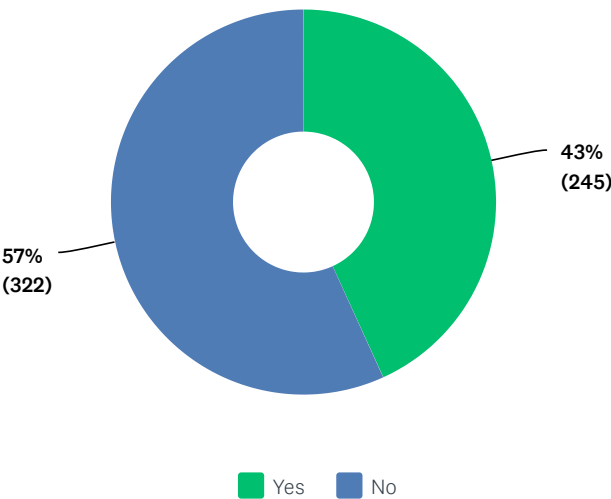

Q19 Are you a parent with children 18 or under living with you at home?

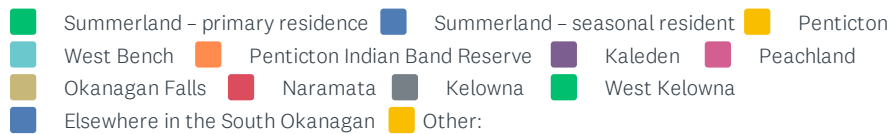
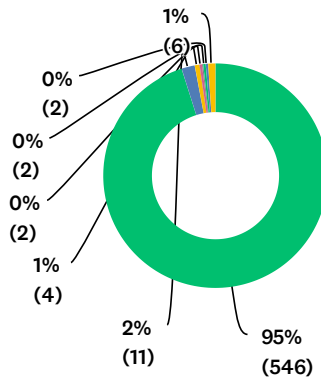

APPENDIX B – PUBLIC OPEN HOUSE SUMMARY

Summerland Open House Key Findings:

Aquatics

- Chlorine alternatives desired
- Rehab activities are a priority; access other than lifts
- Minimum 8 lanes to host sanctioned swim competitions, FINA standards for 25m minimum, Adjacent dry space for training/classes, etc.
- Better viewing area is needed
- Leisure pool to attract the community - Slides, lazy river, separate warm pool
- Universal change rooms / family change rooms

Indoor Recreation

- Meeting rooms are needed for workshops, meetings, and teaching courses
- Fitness with weight room, fitness class space (yoga, tabata, strength, dance)
- Climbing/bouldering wall should be considered (support from survey?)
- Indoor walking track and exercise stations

Gymnasium

- Need a community gymnasium because the school gyms do not have enough access
- Access is needed during school hours and school year (i.e. winter)
- Could a community gymnasium and school gymnasium be connected/combined?
- Space for birthday parties and other celebrations
- Accommodate all types of children's classes
- Gymnasium could potentially provide dry space for the pool?
- The existing secondary school gymnasium is in desperate need of replacing.

Healthcare

- Would be great to have a holistic health centre with a variety of health practitioners
- Needs identified included services for mental health, people with addictions, and low-income, and all ages
- Concern over the model – collaborative approach with a Board with equal representation? What is the business model and how will various agencies contribute?
- Team-based approach to healthcare could result from this model – focus on preventative health
- Could improve continuity of care from primary care to rehabilitation to general community programs
- Could streamline access and help get people to the right services at the right level faster / remove bottlenecks
- Makes sense to combine with recreation

Other

- Dedicated childcare and child-minding space is important; could generate revenue and be a source of grant funding
- Outdoor spaces should also be considered – films, outdoor theatre, performance space for smaller groups and community events
- Aging population with mobility and dementia challenges – should support their independence as much as possible

- Look for many funding sources and strategies
- We need to build the best facility we can now because it will be our only chance for the next 50 years
- Aging population has limited ability to pay
- Multiple partnerships are a good approach
- Need to know what the funding partnership looks like – gov't, docs, etc

APPENDIX C – STAKEHOLDER QUESTIONNAIRE SUMMARY

1 PURPOSE OF QUESTIONNAIRE & STAKEHOLDER OVERVIEW

1.1 PURPOSE OF QUESTIONNAIRE

We reached out to stakeholders from diverse recreational, health and wellness, and community organizations to hear about the needs and priorities of their memberships. In addition to the stakeholder workshops, the questionnaire provided a flexible and accessible opportunity for organizations to share:

- Their organization's vision for the project;
- Their organizations needs and barriers around aquatics, indoor recreation, health care services, wellness services, and other services for children, seniors, and youth;
- Any partnership opportunities they might see within their organizations or the community at large, and
- Their understanding of the willingness and methods to pay for new facilities.

1.2 STAKEHOLDERS

Stakeholders were identified by District of Summerland staff, the project Steering Committee, and the consulting team. All stakeholders were invited to complete a questionnaire providing information about their organization, future needs, potential partnerships, and willingness to pay for a new facility.

Thirty-four respondents, representing twenty-nine recreational, health, and community organizations, responded to the questionnaire. The questionnaire was open from September 2nd to 20th, 2020.

1.2.1 RESPONDING ORGANIZATIONS

Respondents included representatives from:

- **7 community service and/or non-governmental organizations, including senior-serving organizations**
 - Kinsmen Club of Summerland
 - Alzheimer Society of BC (2 responses)
 - Meals on Wheels
 - Summerland Chamber of Commerce (2 responses)

1.2.2 FACILITY NEEDS OF ORGANIZATIONS

To better understand facility needs, stakeholder organizations were asked whether (prior to any COVID-19 related restrictions) their programs were over capacity and unable to take on new participants or under capacity and looking for new participants. Organizations reported that:

- 37% were over capacity
- 30% were at capacity

The availability of facility space and the appropriateness of facility design were two important limiting factors for organizations that were overcapacity, with

- 58% identified lack of facility space
- 42% identified problems with facility design

2 RESULTS OF QUESTIONNAIRE

The following sections describe the key results by topic, pulling together the results from each engagement activity.

2.1 INDOOR RECREATION & ACQUATICS

2.1.1 VISION FOR INDOOR RECREATION & AQUATICS

- When asked about the **vision for aquatics and indoor recreation** in Summerland over the next 50 years, stakeholders responded with the following key words and concepts:
 - Accessible (11/23)
 - All ages (8/23)
 - Multi-use (7/23)
 - A social hub (6/23)
 - Innovative and contemporary (6/23)
 - Support community health, recreation, and wellness (5/23)
- Other important words included:
 - Green and sustainable (2/23)
 - Flexible (2/23)
 - Affordable (2/23)

2.1.2 AQUATICS

When asked about improvements to existing Aquatic centre, the most popular response by far were pool improvements and amenities (14/23). Improvements included:

- Improved change areas, including family and gender neutral changerooms
- Increased capacity (larger size)
- Meeting rooms and rentable party room adjacent to pool
- Lap pool
- Kid-oriented features such as water slide, lazy river, spray play opportunities
- Ability to host swim meets
- Hot tub, sauna, steam room

2.1.3 GYMNASIUM

When asked about whether a dedicated community gymnasium was needed, or whether the existing shared use model should continue, stakeholders favoured:

- A dedicated gym due the scarcity of gym time available at the secondary school (8/24)
- The shared model should continue at the secondary school, as it would enhance fiscal prudence and community-building (8/24)
- Shared access if more access could be dedicated to the community (3/24)

2.1.4 OTHER INDOOR RECREATION

Stakeholders identified indoor recreation facilities and programs that were missing, difficult to access, or needing improvements in Summerland.

- The most common responses were:
 - Meeting, educational, and event rooms (5/20)
 - Amenities and spaces for kids and youth (5/23)
 - Gymnasium (including pickleball, basketball, and indoor volleyball opportunities) (4/23)
 - Indoor walking track (3/20)
 - Indoor tennis (3/20)
- Other responses included:
 - Better fitness centre (2/23)
 - Exercise studio & programs (2/20)

2.1.5 ROOM SIZE

To better understand the most important room sizes for a new recreation and health facility, we asked stakeholders about the average numbers of participants and users they hosted at one time for their programs or services.

- The greatest need is seen for rooms for **11 to 30 people**
 - **12%** - Rooms for 10 or fewer people
 - **58%** - Rooms for 11 to 30 people
 - **19%** - Rooms for 31 to 80 people
 - **12%** - Rooms for 81 people or greater

2.1.6 OTHER COMMUNITY SERVICES

Stakeholders identified community services that are as missing or difficult to access in Summerland.

- Most popular responses were:
 - Meeting rooms and educational spaces (4/18)
 - Family and infant/toddler drop in and programs (3/18)
- Other important missing services mentioned were:
 - Increased youth services (2/18)
 - Daycare, out of school care (2/18)
 - Social services (1/18)

2.1.7 WILLINGNESS TO PAY – RECREATION & AQUATIC CENTRE

We asked, “To what extent does your organization support or oppose the District investing in a new aquatic and indoor recreation centre?”

- There was strong, consensus in support, with
 - **87.5% of stakeholder respondents reported that their organizations would strongly support or somewhat support** the District investing in a new aquatic and indoor recreation centre, and none opposed. (12.5% were neutral).
- It is also important to note that some view a new community centre as a critical piece of community infrastructure, others, noting the high cost, felt there was a need for more informed community feedback and a community referendum.

2.2 PRIMARY CARE AND ALLIED HEALTH SERVICES

2.2.1 VISION FOR HEALTHCARE AND WELLNESS SERVICES

The following key words and concepts were described by stakeholders when asked what their vision was for primary healthcare and wellness services in Summerland over the next 50 years.

- The most common responses were:
 - More access (9/20)
 - Multi-disciplinary (5/20)
 - Comprehensive services (5/20)
 - Innovative (3/20)
- Other important comments included the need for healthcare and wellness services to be:
 - Affordable and inclusive (2/20)
 - Preventative (1/20)

2.2.2 HEALTHCARE AND WELLNESS FACILITIES AND SERVICES NEEDS

When asked what healthcare and wellness facilities and services are currently missing or difficult to access in Summerland, stakeholders mentioned:

- The benefits of having multiple service under one roof (8/16)
- Walk-in clinics with greater access, longer hours, and availability for those without primary care providers (4/16)
- Inclusion of mental health services (3/16)
- More primary care providers (3/16)
- Youth-oriented health and wellness services (2/20)

2.2.3 WILLINGNESS TO PAY – PRIMARY HEALTH CARE CLINIC

We also asked, “To what extent does your organization support or oppose the District of Summerland investing in a new Primary Health Care Clinic as part of a joint project or partnership?”

- There was general, though less emphatic, consensus in support, with **71% of stakeholder respondents reported that their organizations would strongly support or somewhat support** the District investing in a new Primary Health Care Clinic as part of a joint project or partnership and none opposing. It is important to note that 29% were neutral. When given greater information about costs and trade-offs, opposition and neutrality may increase.
- It was also noted that community investment would need to be contingent on the details of how the funding and partnership agreement is constructed.

2.3 OTHER

Other key comments included low user fees, with particular caution around constructing barriers to community health, wellness, and recreation, particularly for those who may be in most need of these services.

ADDENDA ON PARTNERSHIPS:

The following stakeholders shared possible opportunities for partnerships.

- **Long term tenant, possible facility investment:** Summerland Physiotherapy, currently at capacity: “Yes. We would be happy to become long-term tenants of a multi-disciplinary health facility as described above. We would be open to discussions regarding investment into the facility as well.”

APPENDIX D – STAKEHOLDER WORKSHOP SUMMARY

Summerland Stakeholder Workshop Key Findings:

Aquatics

- Key features of the pool are the right depths, accessibility, and space for rehabilitation and fitness.
- If more pool space is available it would expand potential to offer rehabilitation, lap swim, and swimming lessons.
- Provide better and expanded change rooms, family change rooms, accessibility
- Recope / aquafit programs need a variety of depths, as some want shallow and some want deep; there are 11,000 client hours per year and 200 active clients.
- Proper facilities to enable swim meet hosting; question whether regional or bigger competitions should be added
- Main groups that have specific needs are aquafit/rehabilitation users and swim club
 - Very specific design requests were submitted by the swim club including adjacent room for training/dry land classes for 30-50 people and pool meeting FINA depths
- Ensure that the Penticton pool is considered as partly filling the pool gap
- Need a hot pool with good jets (i.e. replace existing)
- Outdoor pool was mentioned – but is this supported elsewhere?

Indoor Recreation

- Indoor walking track would be well-used.
- Expand fitness centre and space for exercise classes
- There are already 2 other dance studios and other community kitchens
- Need room for health and wellness programs
- Need public meeting spaces and places for drop-in interaction and socializing

Indoor Tennis & Pickleball

- There is a need for a place to play tennis year-round. It would be used even in the summer as a place to play out of the sun. Could share with pickleball, volleyball, and other activities. The Lakeshore Racquet Club is interested in a partnership. (PRC, Rec stakeholders)
- Stakeholders see this as a regional facility to serve the whole south Okanagan.
- Ideally, there would be 3 indoor tennis courts.
- There is high demand for pickleball. They use 7 courts 7 days per week with 200 players per week; currently using multiple venues.
- Pickleball could overlap with either indoor tennis courts or a gymnasium.

Gymnasium

- Community access to school gymnasiums has generally not been adequate. There is competition for gymnasium time. If more gymnasium space were available, it would be well-used. (PRC, Rec Stakeholders)
- Gymnasium access demand is greatest during evenings and weekends, so there could be a collaboration with the School Board, but there is uncertainty around whether there will be enough availability. (PRC)
- Summerland is the biggest community in BC without a community gym. Many user groups are underserved. Some drive in from Penticton and other communities.
- Pickleball is in high demand and would use gymnasium space.
- Other gymnasium uses would include volleyball, child drop-in programs

Other Services

- Childcare is a huge need in the community.
- Youth programming space is needed. Current, community organizations can't meet the demand for youth programming. There is a lot of competition for space. Dedicated or purpose-built space is ideal (i.e. designated hours).
- There is a need for basic public hygiene services (i.e. public showers/washroom).
- There is a need to serve new Canadians.
- The Resource Centre already provides space for 16 community organizations in a centralized location.

Specific Activities:

- Pickleball
- Tennis
- Fitness Classes
- Yoga
- Curling

Healthcare

- Could enhance communication/connection between doctors, physios, and wellness programs.
- Could create a collaborative environment to enhance healthcare overall and improve access to a variety of services.
- Could increase physician recruitment.
- The recreation centre should support rehabilitation such as the recope program and healthy heart program.
- Centralized community well-being is a positive. Would enhance access for older adults and bring them into the recreation centre.
- The visibility and awareness of health services is beneficial. There could be promotion of healthy community on all levels.
- There aren't a lot of examples of this model but it seems to have potential.

Vision Words

- Centralization / Central Hub for the community / Core Hub / Complete / Central and Connected / One Stop Shop / Convenient
- Engaging / Unique
- Wellness for Life / Facilitating activity / Recreation = Health / Empower people through recreation / promote active and healthy living
- Together / Inclusive / All ages / Accessible / Multigenerational / Multifunctional / Multipurpose / Flexible
- Affordable / Economic / Economic opportunities / Catalyst for downtown / Holistic cost-benefits

Other

- The facility should be forward thinking.
- Consider all demographics, serve a diverse demographic; specifically mention families, preschool kids winter activities, teens/youth, seniors.
- Accessibility is very important.
- Access to healthy, affordable food / café should be included.
- Heritage carousel could be an attracting amenity
- Visibility of health services could be a benefit

Willingness to Pay/Cost

- Affordability for organizations to be able to rent space. The facility should be practical.
- The cost has to be manageable as this is going to go to a referendum; consider the community budget and small tax base; capitalize on existing facilities and manage the costs/needs. (PRC, community orgs.)
- There are economic benefits to a recreation centre that are often not considered. (PRC)
- You have to weight community needs and the economic benefit of a south Okanagan attraction. (PRC)
- A significant concern around funding and the potential for provincial support and funding. (PRC)
- This type of facility should be considered a service, not a business (community org stakeholders).
- Support existing community services but don't compete with other facilities or the private sector.
- Need to consider possible revenue streams for the new facility

General Design Features

- Lots of light
- Inviting
- Sustainable building strategies / energy efficient / GHG free
- A place to gather and bring the community together
- Adequate parking should be provided.

Barriers

- The municipality has a variety of aging facilities that are widely distributed.
- There is competition for space.
- It is a barrier for many people in the highest need populations to travel to Penticton or between multiple facilities.
- Challenges getting around town and to Penticton impacts older people, youth, those with health challenges, and working families in particular.
