

Municipal Council of the District of Summerland will consider adoption of Bylaws “Permissive Tax Exemption (2027 – 2036, Places of Worship) Bylaw No. 2026-013” and “Permissive Tax Exemption (2027 – 2029, Non-Profit Organizations) Amendment Bylaw No. 2026-017” at a Special Meeting of Council on Friday, October 2, 2026, at 1:00 p.m. Upon adoption, these bylaws will grant exemption from Municipal Property Taxes for the organizations listed below. The estimated value of each exemption is provided based on 2026 property assessments and tax rates.
